## PREFACE

In this book the authors study the zero divisor graph and unit graph of a semigroup.

The zero divisor graphs of semigroups $Z_{n}$ under multiplication is studied and characterized. The zero divisor graphs of the semigroups $\left(Z_{p}, \times\right)$, p a prime are only trees with $p$ vertices. However the zero divisor graph of $\left(Z_{n}, \times\right)$, $n$ a non prime is not a tree. We also define the special zero divisor graph of a semigroup and the S-zero divisor of a semigroup.

We introduce a new notion called the tree covering pseudo lattice. We see the zero divisor graph of $Z_{2 p}$, $p$ a prime is a tree covering pseudo lattice where as the zero divisor graph of $Z_{2 n}$, $n$ a composite number is not a tree covering pseudo lattice.

This study is carried out in chapter two of this book. Chapter one is introductory in nature to make this book a self contained one.

In chapter three we study the unit graphs of semigroups. The unit graphs of the semigroups $Z_{n}$ and $S(n)$ are described. Further unit graphs of the finite complex modulo integers $C\left(Z_{n}\right)$ are analysed.

The S-unit graph of $Z_{p}$, $p$ a prime is a complete graph with ( $\mathrm{p}-1$ ) vertices. In the fourth chapter we suggest over 50 problems.

We thank Dr. K.Kandasamy for proof reading and being extremely supportive.

## Chapter One

## Basc Concepts

In this chapter we introduce some basic concepts about semigroups and graphs. These concepts are mainly given here to make the book a self contained one. This chapter has two sections. Section one gives the types of finite semigroups used in this book. In section two some basic notion about graphs are recalled.

### 1.1 Semigroups

In this section we introduce the notion of finite semigroups and describe their properties.

A non empty set $S$ is said to be a semigroup if on $S$ there is defined a closed binary operation '*' which is also associative. That is for $\mathrm{a}, \mathrm{b} \in \mathrm{S}$ we have $\mathrm{a} * \mathrm{~b} \in \mathrm{~S}$ and $\mathrm{a} *(\mathrm{~b} * \mathrm{c})=(\mathrm{a} * \mathrm{~b}) * \mathrm{c}$ for all $a, b, c \in S$. If in $S$ we have an element $e$ such that $a * e=$ $e^{*} a=a$ for all $a \in S$ then we say $S$ is a semigroup with unit or a monoid.

If in S , '*' is defined in such a way that $\mathrm{a} * \mathrm{~b}=\mathrm{b} * \mathrm{a}$ for all $\mathrm{a}, \mathrm{b} \in \mathrm{S}$ then we call $(\mathrm{S}, *)$ to be a commutative semigroup.

We will give examples of them.
Example 1.1.1: Let $\mathrm{Z}_{6}=\{0,1,2,3, \ldots, 5\} ; \mathrm{Z}_{6}$ under modulo multiplication is a semigroup.

Example 1.1.2: Let $\mathrm{Z}_{17}=\{0,1,2,3, \ldots, 16\}$ be a semigroup under multiplication modulo 17.

Example 1.1.3: Let $\mathrm{P}=\mathrm{Z}_{4} \times \mathrm{Z}_{4} \times \mathrm{Z}_{4}=\left\{(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mid \mathrm{a}, \mathrm{b}, \mathrm{c} \in \mathrm{Z}_{4}\right\}$ be a semigroup under product. That is if $(3,1,0)$ and $(2,3,1)$ are in $P$, then $(3,1,0) \times(2,3,1)=(2,3,0)$. The $\times$ is a modulo multiplication four.

## Example 1.1.4: Let

$$
\mathrm{M}=\left\{\mathrm{Z}_{7} \times \mathrm{Z}_{7} \times \mathrm{Z}_{7}\right\}=\left\{(\mathrm{a}, \mathrm{~b}, \mathrm{c}) \mid \mathrm{a}, \mathrm{~b}, \mathrm{c} \in \mathrm{Z}_{7}\right\} ;
$$

M is a semigroup under product.
We would be considering semigroups only under multiplication as our study pertains to graphs and graphs are of two types zero divisor graphs of the semigroup and the unit graphs of the semigroup.

Suppose ( $\mathrm{S},,^{*}$ ) is a semigroup with 0 . If in S we have $\mathrm{a}, \mathrm{b} \in$ $\mathrm{S} \backslash\{0\}$ such that $\mathrm{a} * \mathrm{~b}=0$ then we say ( $\mathrm{S},{ }^{*}$ ) has zero divisors. If the semigroup $S$ is non commutative we may have in $S$ right zero divisors which are not left zero divisors and vice versa.

Let ( $\mathrm{S},{ }^{*}$ ) be a monoid. We say an element $\mathrm{a} \in \mathrm{S} \backslash\{1,0\}$ is a unit if there exists $\mathrm{ab} \in \mathrm{S} \backslash\{1,0\}$ such that $\mathrm{a}^{*} \mathrm{~b}=1$.

We will illustrate these situations by some examples.
Example 1.1.5: Let $\mathrm{S}=\mathrm{Z}_{14}=\{0,1,2, \ldots, 13\}$ be the semigroup under multiplication modulo 14 .

$$
\begin{aligned}
& 2 \times 7 \equiv 0(\bmod 14) \\
& 4 \times 7 \equiv 0(\bmod 14) \\
& 6 \times 7 \equiv 0(\bmod 14)
\end{aligned}
$$

$$
\begin{gathered}
8 \times 7 \equiv 0(\bmod 14) \text { and } \\
10 \times 7 \equiv 0(\bmod 14) .
\end{gathered}
$$

We see this semigroup also has units; for

$$
\begin{gathered}
3.5 \equiv 1(\bmod 14) \text { and } \\
13.13 \equiv 1(\bmod 14) \text { are units in } S .
\end{gathered}
$$

Example 1.1.6: Let $\mathrm{S}=\mathrm{Z}_{18}=\{0,1,2,3, \ldots, 17\}$ be a semigroup under modulo multiplication.

$$
\begin{array}{ll}
\text { Consider } & 2.9 \equiv 0(\bmod 18) \\
& 3.6 \equiv 0(\bmod 18) \\
& 3.12 \equiv 0(\bmod 18) \\
& 4.9 \equiv 0(\bmod 18) \\
& 6.6 \equiv 0(\bmod 18) \\
& 6.12 \equiv 0(\bmod 18) \\
& 8.9 \equiv 0(\bmod 18) \\
& 9.6 \equiv 0(\bmod 18) \\
& 9.12 \equiv 0(\bmod 18) \\
& 10.9 \equiv 0(\bmod 18)
\end{array}
$$

$12 \times 9 \equiv 0(\bmod 18)$ and so on are zero divisors in $\mathrm{S}=\mathrm{Z}_{18}$.
Now $\mathrm{S}=\mathrm{Z}_{18}$ has also units given in the following.

$$
\begin{gathered}
17 \times 17 \equiv 1(\bmod 18) \\
11 \times 5 \equiv 1(\bmod 18) \text { and } \\
13 \times 7 \equiv 1(\bmod 18) .
\end{gathered}
$$

Thus we have semigroups which has units and zero divisors.
Now we can have units and zero divisors in case of complex modulo integer semigroups $\mathrm{C}\left(\mathrm{Z}_{\mathrm{n}}\right)$ under multiplication [16].

$$
\text { Recall } \mathrm{C}\left(\mathrm{Z}_{\mathrm{n}}\right)=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{a}, \mathrm{~b} \in \mathrm{Z}_{\mathrm{n}} ; \mathrm{i}_{\mathrm{F}}^{2}=\mathrm{n}-1\right\} .
$$

Example 1.1.7: Let $\mathrm{C}\left(\mathrm{Z}_{4}\right)=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{4} ; \mathrm{i}_{\mathrm{F}}^{2}=3\right\}$ be a semigroup under product.

$$
\text { Consider } \begin{aligned}
& 2 \times 2 \equiv 0(\bmod 4) \\
& 2 \times\left(2+2 i_{\mathrm{F}}\right) \equiv 0(\bmod 4) \\
& 2 \mathrm{i}_{\mathrm{F}} \times\left(2+2 \mathrm{i}_{\mathrm{F}}\right) \equiv 0(\bmod 4) \\
&\left(2+2 \mathrm{i}_{\mathrm{F}}\right) \times\left(2+2 \mathrm{i}_{\mathrm{F}}\right) \equiv 0(\bmod 4) \\
& 3 \mathrm{i}_{\mathrm{F}} \times \mathrm{i}_{\mathrm{F}}=1(\bmod 4) \\
& \text { and } 3 \times 3 \equiv 1(\bmod 4) .
\end{aligned}
$$

Thus this finite complex modulo integer semigroup has both units and zero divisors.

Example 1.1.8: $\operatorname{Let} \mathrm{C}\left(\mathrm{Z}_{6}\right)=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{i}_{\mathrm{F}}^{2}=5, \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{6}\right\}$ be a complex modulo integer semigroup. Clearly $\mathrm{C}\left(\mathrm{Z}_{6}\right)$ has both units and zero divisors.

Example 1.1.9: Let $\mathrm{C}\left(\mathrm{Z}_{7}\right)=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{7}, \mathrm{i}_{\mathrm{F}}^{2}=6\right\}$

$$
\begin{aligned}
6 \times 6 & \equiv 1(\bmod 7) \\
5 \times 3 & \equiv 1(\bmod 7) \\
2 \times 4 & \equiv 1(\bmod 7) \\
6 \mathrm{i}_{\mathrm{F}} \times \mathrm{i}_{\mathrm{F}} & \equiv 1(\bmod 7) .
\end{aligned}
$$

However $\mathrm{C}\left(\mathrm{Z}_{7}\right)$ has no zero divisors.
We now proceed onto recall the notion of symmetric semigroup $\mathrm{S}(\mathrm{n})$; that is set of all maps from the set $(1,2,3, \ldots$, n) to itself. Clearly $\mathrm{S}(\mathrm{n})$ is not one to one maps alone [15].

For instance

$$
\mathrm{S}(3)=\left\{\begin{array}{llllll}
1 \rightarrow 1 & 1 \rightarrow 2 & 1 \rightarrow 3 & 1 \rightarrow 3 & 1 \rightarrow 3 & 1 \rightarrow 1 \\
2 \rightarrow 2, & 2 \rightarrow 1, & 2 \rightarrow 1, & 2 \rightarrow 1, & 2 \rightarrow 2,2 \rightarrow 2 \\
3 \rightarrow 3 & 3 \rightarrow 3 & 3 \rightarrow 2 & 3 \rightarrow 2 & 3 \rightarrow 1 & 3 \rightarrow 3
\end{array}\right\}
$$



Clearly this has no zero divisors but has only units.

Example 1.1.10: Let $\mathrm{S}(5)$ be a symmetric semigroup. Clearly $\mathrm{S}(5)$ has no zero divisors and only 120 elements have inverse including the identity.

Now we proceed onto give examples of semigroups got under the natural product $x_{\mathrm{n}}$ and usual matrix product $\times$.

Example 1.1.11: Let $M=\left\{\left.\left[\begin{array}{l}a \\ b\end{array}\right] \right\rvert\, a, b \in Z_{3}\right\}$ be a semigroup under natural product. M has both units and zero divisors.

\begin{gathered}
\text { Consider }\left[\begin{array}{l}

Take $x=\left[\begin{array}{l}1 \\ 0\end{array}\right]$ and $y=\left[\begin{array}{l}0 \\ 2\end{array}\right]$ in M; clearly $x x_{n} y=\left[\begin{array}{l}0 \\ 0\end{array}\right]$.
Likewise $\mathrm{x}=\left[\begin{array}{l}0 \\ 1\end{array}\right]$ and $\mathrm{y}=\left[\begin{array}{l}1 \\ 0\end{array}\right]$ in M contribute to zero divisors.

Example 1.1.12: Let $\mathrm{T}=\left\{(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mid \mathrm{a}, \mathrm{b}, \mathrm{c} \in \mathrm{Z}_{6}\right\}$ be a semigroup under the matrix product. It is important to note that in case of row matrices natural product coincides with the usual matrix product.

Take $\mathrm{x}=(2,0,4)$ and $\mathrm{y}=(3,5,3)$ in T.
Clearly $\mathrm{x} \times \mathrm{y}=\mathrm{x} \times_{\mathrm{n}} \mathrm{y}=\left(\begin{array}{lll}0 & 0 & 0\end{array}\right)$.
Take $\mathrm{x}=(1,5,1)$ and $\mathrm{y}=(1,5,1)$ in T .

Clearly $\mathrm{x} \times \mathrm{y}=(1,1,1)$ is a unit in T .

Also if $\mathrm{a}=(5,5,5)$ are in T we see $\mathrm{a} \times \mathrm{b}=(1,1,1)$
Consider $\mathrm{x}=\left(\begin{array}{lll}1 & 0 & 0\end{array}\right)$ and $\mathrm{y}=\left(\begin{array}{lll}0 & 0 & 3\end{array}\right)$ in $T$, we see $\mathrm{x} \times \mathrm{y}=(0$, $0,0)$. Thus these semigroups have plenty of zero divisors and units. Further o (T) $=6 \times 6 \times 6=216$.

M has zero divisors and no units for $\left[\begin{array}{l}1 \\ 1 \\ 1 \\ 1\end{array}\right]$ is the unit of M .

Take $\mathrm{x}=\left[\begin{array}{l}1 \\ 0 \\ 1 \\ 0\end{array}\right]$ and $\mathrm{y}=\left[\begin{array}{l}0 \\ 1 \\ 0 \\ 1\end{array}\right]$ in $\mathrm{M}, \mathrm{x} \times_{\mathrm{n}} \mathrm{y}=\left[\begin{array}{l}0 \\ 0 \\ 0 \\ 0\end{array}\right]$.

Likewise if $\mathrm{x}=\left[\begin{array}{l}1 \\ 0 \\ 0 \\ 0\end{array}\right]$ we see $\mathrm{y}_{1}=\left[\begin{array}{l}0 \\ 1 \\ 1 \\ 1\end{array}\right], \mathrm{y}_{2}=\left[\begin{array}{l}0 \\ 0 \\ 1 \\ 1\end{array}\right], \mathrm{y}_{3}=\left[\begin{array}{l}0 \\ 1 \\ 0 \\ 1\end{array}\right]$,

For consider $\mathrm{x}=\left[\begin{array}{ll}1 & 3 \\ 4 & 2 \\ 1 & 4\end{array}\right]$ and $\mathrm{y}=\left[\begin{array}{ll}1 & 2 \\ 4 & 3 \\ 1 & 4\end{array}\right]$ in X .

It is easy to verify $\mathrm{x} \times_{\mathrm{n}} \mathrm{y}=\left[\begin{array}{ll}1 & 1 \\ 1 & 1 \\ 1 & 1\end{array}\right]$.

V is a semigroup under usual matrix product and V is a non commutative semigroup with $\left[\begin{array}{ll}1 & 0 \\ 0 & 1\end{array}\right]$ as its unit.

Consider the same $V$ with natural $x_{n}$; clearly $V$ is a commutative semigroup with $\left[\begin{array}{ll}1 & 1 \\ 1 & 1\end{array}\right]$ as its unit.

however $\mathrm{x} \times \mathrm{y} \neq \mathrm{y} \times \mathrm{x}$.
Thus under natural product x and y are inverses of each other.

identity.

Suppose we consider M under the natural product $\times_{\mathrm{n}}$, then
M is commutative and $\left[\begin{array}{lll}1 & 1 & 1 \\ 1 & 1 & 1 \\ 1 & 1 & 1\end{array}\right]$ is the multiplicative identity under the natural product $x_{n}$.

However number of elements in M is the same. M has both units and zero divisors both under usual product $\times$ and natural product $\times_{n}$.

Example 1.1.20: Let

However P has multiplicative identity $\mathrm{I}=\left[\begin{array}{lll}1 & 1 & 1 \\ 1 & 1 & 1 \\ 1 & 1 & 1 \\ 1 & 1 & 1 \\ 1 & 1 & 1\end{array}\right]$.
We see P is not a semigroup under usual product as it is not compatible under usual product. We see $P$ has several zero divisors. Further this semigroup is not a Smarandache semigroup.

## THEOREM 1.1.1: Let

$P=\left\{\right.$ collection of all $m \times n$ matrices with entries from $\left.Z_{2}\right\}(m \neq$ $n$ or $m<n$ or $m>n, m$ and $n$ fixed positive integers). $P$ under natural product $x_{n}$ is a commutative semigroup with unit. $P$ is not a Smarandache semigroup.

Proof is left as an exercise to the reader. The only simple reasoning is that every element in P is a $\mathrm{m} \times \mathrm{n}$ matrix whose entries are either 0 or 1 . We see there is one and only one matrix in P with all one's. This matrix serves as the unit. However every other matrix in P has atleast one zero as its entry so it is not invertible.

THEOREM 1.1.2: Let $P=\{$ collection of all $m \times n$ matrices with entries from $Z_{t} ; t \neq 2 ; m=n$ or $m>n$ or $m<n m$ and $n$
positive integers\} be a semigroup under natural product $x_{n}$. $P$ is a Smarandache semigroup.

The proof is direct for P has more than one $\mathrm{m} \times \mathrm{n}$ matrix X
such that we have a $Y$ with $X \times_{n} Y=\left[\begin{array}{ccccc}1 & 1 & 1 & \ldots & 1 \\ 1 & 1 & 1 & \ldots & 1 \\ \vdots & \vdots & \vdots & & \vdots \\ 1 & 1 & 1 & \ldots & 1\end{array}\right]_{\mathrm{m} \times \mathrm{n}}$.
For example take $\mathrm{P}=\left[5 \times 4\right.$ matrices with entries from $\left.\mathrm{Z}_{8}\right]$. $P$ under natural product $x_{n}$ is a semigroup. Take

Now we proceed onto recall some basic notions about graphs.

### 1.2 Basic notions on Graphs

In this section we just recall some of the basic properties associated with graphs which are essential in this study.

A graph is a pair $\mathrm{G}=(\mathrm{V}, \mathrm{E})$ of sets satisfying $\mathrm{E} \subseteq[\mathrm{V}]^{2}$, thus the elements of E are 2-element subsets of V . To avoid notations ambiguities we shall always assume tacitly that $\mathrm{V} \cap \mathrm{E}$ $=\phi$. The elements of V are the vertices (or nodes or points) of the graph G , the elements of E are its edges (or lines) [5].

We will denote a simple graph with vertices $\{1,2,3, \ldots, 9\}$.


The graph on $V=\{1,2, \ldots, 9\}$ with edge set and
$E=\{\{1,6\},\{2,3\},\{2,4\},\{3,5\},\{2,5\},\{5,6\},\{6,7\}$, $\{7,9\},\{4,8\},\{5,8\},\{6,8\}\}$ as its edge set.

We denote the edge set by $E(G)$ and vertex set by $V(G)$.

Now we also make use of the notion of complete graphs in this book. We see the set of units of a semigroup $\left(Z_{n}, \times\right)$ is a complete graph.

Recall a graph $G$ in which all the vertices in $G$ are pairwise adjacent is called complete.

We see this is a complete graph with two vertices.
 is a complete graph with these vertices.

is a complete graph with four vertices and

is a complete graph with 5 vertices.
We also make use of trees and for basic notion about trees refer [5].

## Chapter Two

## Zero Divisor Graphs of Semgroups

In this chapter we define, derive and give the properties of zero divisor graphs associated with finite semigroups. Further we give a simple model of the zero divisor graphs in case of certain infinite semigroups.

Throughout this book we assume the semigroup is only under the binary operation product. If the semigroup has no zero divisors or zero element under product we see the zero divisor graph is trivial.

DEFINITION 2.1: A semigroup $S$ is considered as a simple graph $G$ whose vertices are elements of $G$ such that two different elements $x$ and $y$ in $G$ are adjacent if and only if $x$ is a zero divisor of $y$.

We will call this graph $G$ as the zero divisor graph of the semigroup S.

Example 2.1: Let $\left(\mathrm{Z}_{4}, \times\right)=\mathrm{S}$ be a semigroup. The zero divisor graph of S is as follows:


Example 2.2: Let $\mathrm{P}=\left(\mathrm{Z}_{6}, \times\right)$ be a semigroup. The zero divisor graph of P is as


Example 2.3: Let $\mathrm{S}=\left(\mathrm{Z}_{7}, \times\right)$ be semigroup under product. The zero divisor graph of S is as follows:


Example 2.4: Let $\mathrm{S}=\left\{\mathrm{Z}_{2}, \times\right\}$ be the semigroup under product. The zero divisor graph of $S$ is a tree with two vertices given by

Example 2.5: Let $\mathrm{S}=\left\{\mathrm{Z}_{5}, \times\right\}$ be the semigroup under product. The zero divisor graph of $S$ is a tree with five vertices given by the following figure.


The following theorem is direct.
THEOREM 2.1: Let $S=\left\{Z_{p}, x\right\}$; ( $p$ a prime) be a semigroup under product. The zero divisor graph of $S$ is a tree with $p$ vertices given by the following diagram.


Proof is direct and hence left as an exercise to the reader.
Example 2.6: Let $\mathrm{S}=\left(\mathrm{Z}_{12}, \times\right)$ be a semigroup. The zero divisor graph of $S$ is as follows:


Example 2.7: Let $\mathrm{S}=\left(\mathrm{Z}_{15}, \times\right)$ be a semigroup. The zero divisor graph of $S$ is as follows.


Example 2.8: Let $\mathrm{S}=\left(\mathrm{Z}_{16}, \times\right)$ be a semigroup. The zero divisor graph of $S$ is as follows.


Now we will provide examples of matrix semigroups some commutative and others non commutative.

Example 2.9: Let $\mathrm{V}=\left\{(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{3}\right\}$ be a semigroup under product. The zero divisor graph of V is as follows.


Example 2.10: Let $\mathrm{S}=\left\{(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{4}\right\}$ be the semigroup.

The zero divisor graph associated with S is as follows:


Likewise we can get the zero divisor semigroup for any $S=\left\{\left(Z_{p_{1}} \times Z_{p_{2}} \times \ldots \times Z_{p_{n}}\right) \mid p_{i}\right.$ are positive integers $\}$.

Example 2.11: Let $\mathrm{M}=\left\{\mathrm{Z}_{2} \times \mathrm{Z}_{3}=(\mathrm{a}, \mathrm{b}) \mid \mathrm{a} \in \mathrm{Z}_{2}\right.$ and $\left.\mathrm{b} \in \mathrm{Z}_{3}\right\}$ be a semigroup under product. The zero divisor graph of M is as follows:

Now we proceed onto show we have a class of semigroups for which we do not have any zero divisor graph associated with them.

Example 2.14: Let $\mathrm{S}(3)$ be the symmetric semigroup of three symbols. $|\mathrm{S}(3)|=27=3^{3}$. Clearly $\mathrm{S}(3)$ has no zero divisor graph associated with it.

Example 2.15: Let $\mathrm{S}(5)$ be the symmetric semigroup of degree 5. $\mathrm{S}(5)$ has no zero divisor. So $\mathrm{S}(5)$ has no zero divisor graph associated with it.

THEOREM 2.3: Let $S(n)$ be the symmetric semigroup. $S(n)$ has no zero divisor graph associated with it.

The proof follows from the simple fact $\mathrm{S}(\mathrm{n})$ has no zero.
Example 2.16: Let $\mathrm{M}=\{0,2,4,6,8.10,12,14\} \subseteq \mathrm{Z}_{16}$ be the semigroup under multiplication modulo 16. The zero divisor graph associated with M is as follows:


Example 2.17: Let $\mathrm{S}=\{0,2,4,6,8,10\}$ be a semigroup under multiplication modulo 12. The zero divisor graph associated with S is as follows:


Example 2.18: Let $\mathrm{S}=\{0,2,4\}$ be a semigroup under multiplication modulo 6 . The zero divisor graph of S is as follows:

In view of all these examples we have the following theorem.

Theorem 2.4: Let $S=\{0,2,4,6, \ldots, 2 p-2\}$ be a semigroup under multiplication modulo $2 p$ p a prime. The zero divisor graph of $S$ is a tree with $p$ vertices.

Proof: The zero divisor graph associated with S is as follows:


Consider the following examples.

Example 2.21: Let $\mathrm{S}=\{0,3,6,9,12\} \subseteq \mathrm{Z}_{15}$ be the semigroup under product modulo 15 . The zero divisor graph associated with S is as follows:


Example 2.22: Let $\mathrm{S}=\{0,3,6,9,12,15,18\}$ be a semigroup under multiplication modulo 21 . The zero divisor graph associated with S is a tree with 7 vertices.


Example 2.23: Let $\mathrm{S}=\{0,3,6,9,12,15, \ldots, 30\} \subseteq \mathrm{Z}_{33}$ be a semigroup under multiplication modulo 33. The zero divisor graph associated with S is a tree with 11 vertices which is as follows:


In view of all these we have the following theorem.
THEOREM 2.5: Let $S=\{0,3,6,9,12, \ldots, 3 p-3 \mid p$ is a prime $\}$ be a semigroup under multiplication modulo $3 p$.

The zero divisor graph of $S$ is a tree with $p$ vertices.
Proof: We see S has no zero divisors other than the trivial ones that is $0 s=0$ for all $s \in S$.

The zero divisor graph of $S$ is as follows:


Clearly this graph is a tree with p vertices.
Consider $\mathrm{Z}_{\mathrm{n}}$ where $\mathrm{n}=\mathrm{pq}$ where p and q are primes $\mathrm{p} \neq \mathrm{q}$. Take $S_{1}=\{0, p, 2 p, \ldots, q p-p\}$ and $S_{2}=\{0, q, 2 q, 3 q, \ldots, p q-$ $q\}$ two proper subsets of $Z_{n}$. Both $S_{1}$ and $S_{2}$ are semigroups under multiplication modulo pq. Further the zero divisor graph associated with $\mathrm{S}_{\mathrm{i}}$ are trees; $1 \leq \mathrm{i} \leq 2$. The graph of $\mathrm{S}_{1}$ has q vertices and that of $S_{2}$ has $p$ vertices.

We illustrate this by examples.
Example 2.24: Let $\mathrm{S}=\mathrm{Z}_{65}$ be a semigroup under multiplication modulo 65. Consider $\mathrm{P}_{1}=\{0,5,10, \ldots, 60\} \subseteq \mathrm{S}$ and $\mathrm{P}_{2}=\{0$, $13,26, \ldots, 52\} \subseteq \mathrm{S}$ subsemigroups of S . Both $\mathrm{P}_{1}$ and $\mathrm{P}_{2}$ have zero divisor graphs to be trees with 13 and 5 vertices respectively.

The zero divisor graph of $\mathrm{P}_{1}$ is as follows:


The zero divisor graph associated with $P_{2}$ is a tree with 5 vertices.


Example 2.25: Let $\mathrm{S}=\mathrm{Z}_{77}$ be a semigroup under multiplication modulo 77. Consider $\mathrm{P}_{1}=\{0,11,22,33,44,55,66\} \subseteq \mathrm{S}$ and $P_{2}=\{0,7,4, \ldots, 70\} \subseteq S$; both $P_{1}$ and $P_{2}$ are subsemigroups and the associated zero divisor graphs of $P_{1}$ and $P_{2}$ are trees with 7 and 11 vertices respectively given by the following graphs.


In view of this we have the following theorem.
THEOREM 2.6: Let $S=Z_{p q}, p$ and $q$ two distinct primes be a semigroup under multiplication modulo pq. $P_{1}=\{0, p, 2 p, \ldots$, $p q-p\}$ and $P_{2}=\{0, q, 2 q, \ldots, p q-q\}$ be two subsemigroups of $S$. Clearly the zero divisor graphs associated with $P_{1}$ and $P_{2}$ are trees with $q$ and $p$ vertices respectively.

The proof is direct hence left as an exercise to the reader.
Example 2.26: Let $\mathrm{S}=\mathrm{Z}_{30}$ be a semigroup under multiplication modulo 30. Take $\mathrm{P}_{1}=\{0,2,4,6, \ldots, 28\}, \mathrm{P}_{2}=\{0,3,6,9, \ldots$, $27\}$ and $\mathrm{P}_{3}=\{0,5,10,15,20,25\}$ be subsemigroups of S . Clearly the zero divisor graphs of $\mathrm{P}_{1}, \mathrm{P}_{2}$ and $\mathrm{P}_{3}$ are not trees. For

In view of this example we have the following theorem.
THEOREM 2.7: Let $S=Z_{n}$ where $n=p q r$ where $p, q$ and $r$ are three distinct primes. Suppose $P_{1}=\{0, p, 2 p, \ldots, p q r-p\}$ and $P_{2}$ $=\{0, q, 2 q, \ldots, p q r-q\}$ and $P_{3}=\{0, r, 23 r, \ldots, p q r-r\}$ be three subsemigroups of $S$. The zero divisor graphs of $P_{1}, P_{2}$ and $P_{3}$ are not trees.

Proof follows from the simple fact $p_{i}$ 's have non trivial zero divisors $1 \leq \mathrm{i} \leq 3$.

Example 2.27: Let $\mathrm{S}=\mathrm{Z}_{12}$ be a semigroup under product modulo 12. The zero divisor graph of S is as follows:


Consider $\mathrm{P}_{1}=\{0,2,4,6,8,10\}$ the subsemigroup of S . The zero divisor graph of $\mathrm{P}_{1}$ is as follows:


Consider the subsemigroup $P_{2}=\{0,3,6,9\}$ of $S$. The zero divisor graph of $\mathrm{P}_{2}$ is as follows:

Now we define special subgraphs in view of these examples.
DEFINITION 2.2: Let $S$ be a semigroup. The zero divisor graph of $S$ be $G$. Suppose $P_{1}, P_{2}, \ldots, P_{t}$ are subsemigroups of $S$. Suppose $G_{1}, G_{2}, \ldots, G_{t}$ be the zero divisor graphs of $P_{1}, P_{2}, \ldots$, $P_{t}$ respectively. Then we define $G_{1}, G_{2}, \ldots, G_{t}$ as special subgraphs of $G$.

Theorem 2.8: Let $S$ be a semigroup. $G$ be the zero divisor graph of $S$. Suppose $P_{1}, P_{2}, \ldots, P_{t}$ are subsemigroups and $G_{1}$, $G_{2}, \ldots, G_{t}$ are the associated special subgraphs of $G$ respectively. Then every special subgraph of $G$ is a subgraph but a subgraph of $G$ in general is not a special subgraph of $G$.

Proof: The first part is clear as every special subgraph of G is also a subgraph of G. To prove the converse we illustrate this situation by an example.

Consider $\mathrm{S}=\mathrm{Z}_{10}$ the semigroup under multiplication modulo 10. The zero divisor graph associated with S is as follows:


The subsemigroups of $S$ are $P_{1}=\{0,5\}$ and $P_{2}=\{0,2,4,6,8\}$. Now the zero graph of $\mathrm{P}_{1}$ is


The zero divisor graph of $\mathrm{P}_{2}$ is


Both of them are trees with two and five vertices respectively. Consider the subgraph


Clearly $S_{1}=\{0,1,3,5,7,9\}$ is a subsemigroup of $S$. So this is also a special subgraph.


This is a subgraph of $G$ but is not a subsemigroup as $P=\{0$, $7,9\}$ is only a subset of $S$ and $7.9 \equiv 63(\bmod 10)=3 \notin \mathrm{P}$. Hence a subgraph in general is not a special subgraph of $S$.

Example 2.33: Let $\mathrm{S}=\mathrm{Z}_{31}$ be a semigroup under product modulo 31. The zero divisor graph of $S$ is a tree and it has only one special subgraph which is also tree with three vertices.

THEOREM 2.9: Let $S=Z_{p}$ be a semigroup under multiplication modulo $p$. The zero divisor graph of $Z_{p}$ has only two special subgraphs which is a tree with 3 vertices and 2 vertices.

Proof: Obvious from the fact that the zero divisor graph associated with the semigroup $S=Z_{p}$ is a tree with $p$ vertices.


Now the two subsemigroups of S are $\mathrm{P}_{1}=\{0,1\}$ and $P_{2}=\{0,1, p-1\}$. The special subgraphs associated with $P_{1}$ and $\mathrm{P}_{2}$ are respectively.


Hence the theorem.

However the graph has several subgraphs which are not special subgraphs.

Now we proceed onto give the zero divisor graphs of semigroups which are matrices.

Example 2.35: Let $\mathrm{S}=\{(\mathrm{Z} \times \mathrm{Z})=(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{S}\}$ be a semigroup. The zero divisors in $S$ are of the form $\{(\mathrm{a}, 0)$ and $(0, \mathrm{~b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}\}$.

The pattern of the zero divisor graph of S will contain subgraphs of the form which is not a tree.


Example 2.36: Suppose $\mathrm{S}=\{(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mid \mathrm{a}, \mathrm{b}, \mathrm{c} \in \mathrm{R}\}$ be an infinite semigroup under product. The pattern of the zero divisor subgraph of S is as follows:


Likewise if we have the semigroup to be a row vector X (or column vector semigroup under natural product $x_{n}$ ) we will get the same pattern of the zero divisor graph.

We have different types of zero divisor graphs if we use matrices, however matrices, under natural product have different patterns.

This will be the universal pattern of the zero divisor subgraph graph when S is an infinite semigroup or a finite semigroup.

This is the zero divisor graph pattern associated with $2 \times 2$ matrices with entries from $Z$ or $Q$ or $R$ or $Z_{n}$.

Likewise one can get the zero divisor graph patterns of any $\mathrm{m} \times \mathrm{n}$ matrix $\mathrm{m} \neq \mathrm{n}$.

The following result is interesting.

## Theorem 2.10: Let

$S=\left\{m \times n\right.$ matrices with entries from $Z$ or $Q$ or $R$ or $\left.Z_{n}\right\}$
be a semigroup under natural product. The zero divisor graph pattern of $S$ is not a tree. But there exists subsemigroups of $S$ which has the pattern of special subgraphs to be trees.

Proof is direct hence left as an exercise to the reader.
We give an example to substantiate the latter part of the theorem.

is a tree with four vertices.

Example 3.40: Let $\mathrm{S}=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{3}, \mathrm{i}_{\mathrm{F}}^{2}=2\right\}$ be a complex modulo integer semigroup.

The zero divisor graph of $S$ is as follows:


It is a tree with 9 vertices.
Example 3.41: Let $\mathrm{S}=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{4}, \mathrm{i}_{\mathrm{F}}^{2}=3\right\}$ be a semigroup under multiplication modulo four.

The zero divisor graph associated with S is not a tree.
However this has subgraphs which are trees.


This is a special graph with four vertices which is not a tree. Inview of all these we have the following theorem.

THEOREM 2.11: Let $V=\left\{a+b i_{F} \mid a, b \in Z_{n}, \mathrm{i}_{\mathrm{F}}^{2}=n-1\right\}$ be $a$ semigroup under product modulo $n$. This has a zero divisor graph with $n^{2}$ vertices. Further $V$ has subsemigroups which have special subgraphs some of which are trees.

Proof: The proof is simple and this tree

with 5 vertices is associated with a subsemigroup $\mathrm{H}=\left\{0,1, \mathrm{i}_{\mathrm{F}},(\mathrm{n}-1) \mathrm{i}_{\mathrm{F}}, \mathrm{n}-1\right\}$.

If n is not a prime certainly this has special subgraphs which are not trees.

Now we just recall the notion of Smarandache zero divisors and the related Smarandache zero divisor graphs.

Let $(\mathrm{S}, \times$ ) be a semigroup with 0 . A element $\mathrm{x} \in \mathrm{S}$ is said to be a Smarandache zero divisor of $S$ if $x \neq 0$ and there exists $y \in$ S with $\mathrm{x} \times \mathrm{y}=0$, further there exists $\mathrm{a}, \mathrm{b} \in \mathrm{S} \backslash\{0, \mathrm{x}, \mathrm{y}\}$ with xa $=0$ or $\mathrm{ax}=0$ and $\mathrm{yb}=0$ and $\mathrm{by}=0$ but $\mathrm{ab} \neq 0$ or $\mathrm{ba} \neq 0$.

We will illustrate this situation by some examples.
Example 2.42: Let $\mathrm{S}=\left\{\mathrm{Z}_{8}, \times\right\}$ be a semigroup with zero.
The zero divisors of S are

Consider $8 \in S, 8 \times 12 \equiv 0(\bmod 16) 6$ and 4 in $S$ are such that $6 \times 8 \equiv 0(\bmod 16) 12 \times 4 \equiv 0(\bmod 16)$ but $6 \times 4 \equiv 0(\bmod$ 16).

Thus 12 and 8 are a S-unit of S. The S-unit graph of 12 and 8 is as follows:


Clearly the S-unit set $\{0,4,6,8,12\}$ forms a subsemigroup of S , seen from the following table.

We see $9($ and 18$)$ alone is the S-zero divisor. $9 \times 18 \equiv 0(\bmod$ 27) and we can have 15 pairs ( $\mathrm{x}, \mathrm{y}$ ) of elements such that $\mathrm{y} \times 18$ $\equiv 0(\bmod 27)$ and $\mathrm{x} \times 9 \equiv 0(\bmod 27)$ with $\mathrm{x} \times \mathrm{y} \neq 0(\bmod 27)$.

The 15 sets are $(3,6),(3,12),(3,15),(3,21),(3,24)$, $(6,12),(6,15),(6,21),(6,24),(12,15),(12,21),(12,24)$, $(21,24),(21,15)$ and $(24,15)$.

Can the semigroup $S=\left\{Z_{p^{3}}, \times\right\} p$ a prime have more than ( $\mathrm{p}-1$ ), S-zero divisors? p a prime.

Example 2.45: Let $\mathrm{S}=\left\{\mathrm{Z}_{24}, \times\right\}$ be a semigroup. We find the S-zero divisors graph, special zero divisor graph and the zero divisor graph of S .

$14 \times 12 \equiv 0(\bmod 24), 20 \times 12 \equiv 0(\bmod 22)$,
$21 \times 8 \equiv 0(\bmod 24), 9 \times 8 \equiv 0(\bmod 24)$.

## Example 2.53: Let $\mathrm{S}=\left\{\mathrm{Z}_{10}, \times\right\}$ be a semigroup.

The zero divisor graph of S is as follows:


This is tree covering pseudo lattice.
Example 2.54: Let $\mathrm{S}=\left\{\mathrm{Z}_{12}, \times\right\}$ be a semigroup. The zero divisor graph of S is as follows:


Clearly this is not a tree covering pseudo lattice.
Example 2.55: Let $\mathrm{S}=\left\{\mathrm{Z}_{14}, \times\right\}$ be a semigroup.
The zero divisor graph of $S$ is as follows:


Clearly the graph is a tree covering pseudo lattice graph.
Example 2.56: Let $\mathrm{S}=\left\{\mathrm{Z}_{22}, \times\right\}$ be a semigroup. The zero divisor graph of S is as follows:

In view of all these we have the following result.

THEOREM 2.12: Let $S=\left\{Z_{2 p}, x \mid p\right.$ is a prime $\}$ be a semigroup. The zero divisor graph of $S$ is a tree covering pseudo lattice graph. $p$ vertices for the tree and the pseudo lattice has ( $p+1$ ) vertices.

The proof is simple and hence is left as an exercise to the reader.

Theorem 2.13: Let $S=\left\{Z_{2 n}, x, n\right.$ is not a prime $\}$ be $a$ semigroup. The zero divisor graph of $S$ is not a tree covering pseudo lattice.

This is evident from several examples given earlier. We can also call these graphs as top tree covering pseudo lattice graph. However we have to test for the certain semigroups.

Example 2.57: Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{4}\right), \times\right\}$ be a semigroup. To find S zero divisors in $S$. The zero divisors of $S$ are $\left\{0,2,2 \mathrm{i}_{\mathrm{F}}, 2+2 \mathrm{i}_{\mathrm{F}}\right.$, $\left.\left(2+2 \mathrm{i}_{\mathrm{F}}\right),\left(3+\mathrm{i}_{\mathrm{F}}\right),\left(2+2 \mathrm{i}_{\mathrm{F}}\right),\left(1+3 \mathrm{i}_{\mathrm{F}}\right),\left(3+3 \mathrm{i}_{\mathrm{F}}\right)\left(2+2 \mathrm{i}_{\mathrm{F}}\right)\left(1+\mathrm{i}_{\mathrm{F}}\right)\left(2+2 \mathrm{i}_{\mathrm{F}}\right)\right\}$

The zero divisors graph of S is as follows:

However the zero divisor graph of S is not a tree covering pseudo lattice.

Example 2.58: Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{5}\right), \times\right\}$ be a semigroup under product.

The zero divisors of S are $\left\{0,\left(4+2 \mathrm{i}_{\mathrm{F}}\right)\left(2 \mathrm{i}_{\mathrm{F}}+1\right)=0\right.$, $\left(3 \mathrm{i}_{\mathrm{F}}+1\right),\left(4+3 \mathrm{i}_{\mathrm{F}}\right)=0,\left(2+\mathrm{i}_{\mathrm{F}}\right)\left(4 \mathrm{i}_{\mathrm{F}}+2\right) \equiv 0(\bmod 5)$,

We see $S=\left\{C\left(Z_{5}\right), \times\right\}$ has S-zero divisors.
Infact this gives a layer of zero divisors which will be defined as the n -layered pseudo zero divisors.

DEfinition 2.3: Let $S$ be a semigroup under product. Suppose $x_{1} y_{1}=0, x_{2} y_{2}=0, \ldots, x_{n} y_{n}=0$ with $x_{i} x_{j}=0$ if $i \neq j, y_{k} y_{t}=0$ if $k \neq t$ then we call the set of zero divisors to be a n-layered pseudo S-zero divisors.

In example 2.58 the semigroup $S=\left\{C\left(Z_{5}\right), \times\right\}$ is a 4-layered pseudo zero divisor.

We see several interesting results in this direction can be derived we suggest some open problems.

Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{13}\right), \times\right\}$ be a semigroup. Will S have 12 layered pseudo S -zero divisor?

## Chapter Three

## Unt Graphs of Semgroups

In this chapter we introduce the notion of special unit graphs of semigroups and study the properties associated with them.

Definition 3.1: Let $S$ be a semigroup with unit 1 under product. A semigroup $S$ is considered as a simple graph $G$ whose vertices are elements of $G$ such that two different elements $x$ and $y$ in $G$ are adjacent if and only if $x$ is a inverse of $y$ and vice versa all elements are adjacent with 1 that is an edge joins every element with 1 . We call these graphs special unit graph.

We will illustrate this situation by some examples.
Example 3.1: Let $S=Z_{3}$ be a semigroup under multiplication the special unit graph of $S$ is


Example 3.2: Let $\mathrm{S}=\mathrm{Z}_{5}$ be a semigroup under multiplication modulo five. The special unit graph of S is as follows:


Example 3.3: Let $\mathrm{S}=\mathrm{Z}_{6}$ be a semigroup under product. The special unit graph of S is as follows:


This is a tree.
Example 3.4: Let $\mathrm{S}=\mathrm{Z}_{7}$ be a semigroup under product modulo 7. The special unit graph of $S$ is as follows:


This graph is not a tree.
Now in view of this we have the following theorem.
THEOREM 3.1: Let $S=Z_{p}$ (p a prime) be a semigroup under product. The special unit graph of $S$ is not a tree.

Proof : Follows from the simple observation every element in $\mathrm{Z}_{\mathrm{p}} \backslash\{0\}$ is a unit in S .

Example 3.5: Let $\mathrm{S}=\mathrm{Z}_{15}$ be a semigroup under product. The special unit graph associated with S is as follows:


This graph is not a tree.
Example 3.6: Let $\mathrm{S}=\mathrm{Z}_{6}$ be a semigroup under product. The special unit graph associated with S is as follows:


This is a tree with 6 vertices.
Example 3.7: Let $\mathrm{S}=\mathrm{Z}_{8}$ be a semigroup under product modulo 8. The special unit graph associated with S is as follows:


This is also a tree.
Example 3.8: Let $\mathrm{Z}_{10}=\mathrm{S}$ be a semigroup under product modulo 10. The special unit graph of $\mathrm{Z}_{10}$ is as follows:


Clearly it is not a tree.
It has subsemigroups whose unit special subgraphs can only be trees.

The subsemigroups of $Z_{10}$ are $P_{1}=\{0,1,5\}$ and $P_{2}=\{0,2$, $4,6,8,1\}$. The unit special subgraphs of $P_{1}$ and $P_{2}$ are as follows:


The special subgraph of $\mathrm{P}_{1}$ is a tree.
Now we consider the subsemigroup $P_{2}$, the associated special subgraph of $\mathrm{P}_{2}$ is as follows:


We see the special subgraph associated with $P_{2}$ is a tree with six vertices.

Example 3.9: Let $\mathrm{S}=\mathrm{Z}_{12}$ be a semigroup. The special unit graph associated with S is as follows:


It is a tree with 12 vertices.
Consider the subsemigroups of $\mathrm{S} ; \mathrm{P}_{1}=\{1,0,2,4,6,8,10\}$ $P_{2}=\{1,0,3,6,9\}, P_{3}=\{0,1,6\}$ and $P_{4}=\{0,4,1,8\}$.

The special unit special subgraphs associated with $\mathrm{P}_{1}, \mathrm{P}_{2}, \mathrm{P}_{3}$ and $\mathrm{P}_{4}$ is as follows:

The special subgraph of $P_{1}$ is

is a tree with 7 vertices.
The special subgraph of $\mathrm{P}_{2}$ is a tree with 5 vertices.


The special subgraph of $\mathrm{P}_{3}$ is also a tree with three vertices.


The special subgraph of $\mathrm{P}_{4}$ is a tree with 4 vertices.


The special unit graph associated with row vector semigroup and column vector semigroup are as follows:

Example 3.10: Let $\mathrm{S}=\left\{(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{3}\right\}$ be a semigroup under product. The special unit graph of S is as follows.


This is clearly a tree and has special subgraphs which are also trees.

All units are self units that is $\mathrm{x}^{2}=(1,1)$ for $\mathrm{x}=(1,2),(2,1)$ and $(2,2)$.

Example 3.11: Let $\mathrm{S}=\left\{(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mid \mathrm{a}, \mathrm{b}, \mathrm{c} \in \mathrm{Z}_{2}\right\}$ be a semigroup under product. The special unit graph of S is as followsL


This graph is a tree with 8 vertices. In view of this we have the following theorem.

THEOREM 3.2: Let $S=\left\{\left(x_{1}, x_{2}, \ldots, x_{n}\right) \mid x_{i} \in Z_{2} ; 1 \leq i \leq n\right\}$ be a semigroup under product. The special unit graph of $S$ is a tree with $2^{n}$ vertices.

The proof is straight forward and hence is left as an exercise to the reader.

Example 3.12: Let $\mathrm{S}=\left\{(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{5}\right\}$ be a semigroup under product.

The special unit graph of $S$ is as follows:


Clearly the special unit graph of S is not a tree and the graph has 25 vertices.

Inview of this we have the following theorem.
THEOREM 3.3: Let $V=Z_{p} \times Z_{p}=\left\{(a, b) \mid a, b \in Z_{p} ; p\right.$ a prime $\}$ be a semigroup under product modulo $p$. $V$ has a special unit graph with $p^{2}$ vertices which is not a tree.

Proof: Follows from the simple fact

\mathrm{x}=\left(\frac{(\mathrm{p}+1)}{2}, \frac{\mathrm{p}-1}{2}\right) \text { and }\left(\frac{\mathrm{p}-1}{2}, \frac{\mathrm{p}+1}{2}\right)=\mathrm{y}

in $V$ are such that $x y=(1,1)$.
Hence is not a tree.

Now we proceed onto define symmetric semigroups and the special unit graphs associated with them.

Example 3.13: Let V $=\mathrm{S}(3)$ be the symmetric semigroup of degree 3. The special unit graph associated with V is as follows: Clearly $\mathrm{o}(\mathrm{S}(3))=3^{3}=27$.


Example 3.14: Let S (4) be a symmetric semigroup of four elements ( $1,2,3,4$ ). The unit graph of $S(4)$ is as follows:


The special unit graph is not a tree.
Example 3.15: Let $\mathrm{V}=\left\{\mathrm{Z}_{2} \times \mathrm{Z}_{3}=(\mathrm{a}, \mathrm{b}) \mid \mathrm{a} \in \mathrm{Z}_{2}\right.$ and $\left.\mathrm{b} \in \mathrm{Z}_{3}\right\}$ be a semigroup. The special unit graph of V is tree which as follows:


V is a tree with six vertices.
Example 3.16: Let $\mathrm{V}=\left\{\mathrm{Z}_{2} \times \mathrm{Z}_{4}=(\mathrm{a}, \mathrm{b}) \mid \mathrm{a} \in \mathrm{Z}_{2}\right.$ and $\left.\mathrm{b} \in \mathrm{Z}_{4}\right\}$ be a semigroup.

The special unit graph is a tree which is as follows:


Example 3.17: Consider the semigroup
$S=\left\{Z_{3} \times Z_{4}=(a, b) \mid a \in Z_{3}, b \in Z_{4}\right\}$. The special unit graph of $S$ is as follows:


We see the special unit graph of $S$ is tree with 12 vertices.

Example 3.18: Let $\mathrm{S}=\left\{\mathrm{Z}_{4} \times \mathrm{Z}_{4}=(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{4}\right\}$ be a semigroup. The special unit graph of S is a semigroup which is tree with 16 vertices.

Example 3.19: Let $\mathrm{S}=\left\{(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{\mathrm{p}}, \mathrm{p}\right.$ a prime $\}$ be a semigroup. The special unit graph of $S$ is not a tree ( $p>2$ ).

The special unit graph of the semigroup

Clearly the graph is a tree.
Example 3.20: Let $\mathrm{S}=\left\{\mathrm{Z}_{2} \times \mathrm{Z}_{2} \times \mathrm{Z}_{2}=(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mid \mathrm{a}, \mathrm{b}, \mathrm{c} \in \mathrm{Z}_{2}\right\}$ be a semigroup under product.


The special unit graph of $S$ is a tree with 8 vertices.
Now we find the zero divisor graph and the special unit graph of a semigroup of finite order.

Example 3.21: Let $\mathrm{S}=\mathrm{Z}_{7}$ be a finite semigroup.

The special unit graph of $Z_{7}$ is


The zero divisor graph of $\mathrm{Z}_{7}$ is a tree.


We see the both are distinct.
We see one is tree and the other is not a tree.
Example 3.22: Let $\mathrm{S}=\mathrm{Z}_{6}$ be the semigroup. The zero divisor graph of $S$ is


The special unit graph of $S$ is a tree


We see the zero divisor graph of $\mathrm{Z}_{6}$ is not a tree where as the special unit graph of $\mathrm{Z}_{6}$ is a tree.

We see if in $Z_{n}, n$ is a prime the zero divisor graph is a tree where as the special unit graph is not a tree where as if n is a composite number than the zero divisor graph is not a tree and the special unit graph may be a tree or may not be a tree. This is evident from the following examples.

Example 3.23: Let $S=Z_{15}$ be the semigroup under multiplication modulo 15.


Clearly the zero divisor graph is not a tree.
Now consider the special unit graph of $\mathrm{Z}_{15}$.


We see the special unit graph of $\mathrm{Z}_{15}$ is not a tree.
Example 3.24: Let $\mathrm{Z}=\mathrm{S}$ be the semigroup under multiplication modulo 9.

The special unit graph of $Z_{9}$ is as follows.


Clearly the graph is not a tree. Consider the zero divisor graph of $Z$.


This is also not a tree.
In case of $\mathrm{Z}_{9}$ and $\mathrm{Z}_{15}$ we see both the zero graph and the special unit graphs are not trees where as in $\mathrm{Z}_{6}$ the zero divisor graph is not a tree where as the special unit graph is a tree.

We see the special unit graph and the zero divisor graph of $Z_{10}$. The special unit graph of $Z_{10}$ is


The zero divisor graph of $\mathrm{Z}_{10}$ is as follows:


This is not a tree.
Example 3.25: Let $\mathrm{S}=\mathrm{Z}_{6} \times \mathrm{Z}_{2}$ be a semigroup under product with 12 elements.


The zero divisor graph is not a tree.
The special unit graph of $S$ is as follows:


Clearly it is not a tree with 12 vertices.
Example 3.26: Let $\mathrm{M}=\mathrm{Z}_{4} \times \mathrm{Z}_{4}$ be a semigroup under product.
The zero divisor graph of M is as follows:


This is not a tree.
The special unit graph of $M$ is as follows:

$(0,1)(0,3)(0,2)$

Clearly M is a tree.
We are not in a position to obtain connected special features for zero divisor graph and the special unit graph.

Next we proceed onto define Smarandache unit graph of a semigroup, zero divisor graph and unit graph of a semigroup.

Let $S$ be a semigroup. If there exist $G \subseteq S$ such that $G$ is a group of $S$. G a proper subset of $S$ then we know $S$ is a Smarandache semigroup. The Smarandache unit graph is
nothing but the identity graph of $G$ and rest of the elements of the semigroup S stand as vertices which are not connected.

We will illustrate this situation by an example.
Example 3.27: Let $\mathrm{S}=\mathrm{Z}_{4}$ be a semigroup under multiplication modulo four. $G=\{1,3\} \subseteq S$ is a group.

The Smarandache unit graph of S is


Example 3.28: Let $\mathrm{S}=\mathrm{Z}_{5}$ be a S-semigroup under multiplication modulo 5. The Smarandache unit graph of $S$ is

We see almost all S-semigroups which are zero divisors and units have a nontrivial S-unit graph.

## Example 3.33: Let

$\mathrm{M}=\left\{\left(2 \mathrm{Z}_{8}, 2 \mathrm{Z}_{6}\right)=(\mathrm{a}, \mathrm{b}) \mid \mathrm{a} \in 2 \mathrm{Z}_{8}=\{0,2,4,6\}\right.$ and $\mathrm{b} \in 2 \mathrm{Z}_{6}=$ $\{0,2,4\}\}$ be a semigroup. Clearly M is not a S -semigroup. Hence the question of S-unit graph does not arise.

Thus we have class of S -semigroups for which S unit graphs do not exists.

THEOREM 3.4: Let $S=\left\{p_{i} Z_{n}\left|p_{i}\right| n ; 1 \leq i \leq t\right.$ where $n=p_{1}, \ldots$, $p_{t}, p_{1}, p_{2}, \ldots, p_{1}$ are distinct primes\} be a semigroups under product $\}$. Only those semigroups which are $S$-semigroups have S-unit graphs associated with them even though $S$ does not contain 1.

This proof will be understood by the reader once he/she understands the following examples.

Example 3.34: Let $\mathrm{S}=\left\{10 \mathrm{Z}_{30}=\{0,10,20\}\right\}$ be a semigroup under product. S is a S -semigroup with 10 as its unit $\mathrm{G}=\{10$, $20\}$ is a group given by the following table.

From this example we see $n Z_{18}$ for $n=2,3,6,12,9$ is a $S$ semigroup so the S -unit graph does not exist for $\mathrm{n} \mathrm{Z}_{18}$ but S -unit graph exist for $\mathrm{Z}_{18}$.

Example 3.36: Let $\mathrm{M}=\left(\mathrm{Z}_{35}, \times\right)$ be a semigroup under product $\times$ modulo 35. Take $P_{1}=\{34,1,0\} \subseteq M ; P_{1}$ is a subsemigroup. Infact $P_{1}$ is a S-semigroup. $P_{2}=\{0,5,25,20,30,10,15\} \subseteq M$ is a semigroup.

The unit graph associated with $\mathrm{P}_{1}$ is


The zero divisor graph associated with $\mathrm{P}_{2}$ is


We see $P_{2}$ cannot have a unit graph associated with it as $\mathrm{P}_{2} \subseteq \mathrm{Z}_{35}$ and 1 is its unit.

If we take $P_{2}$ as a $S$-semigroup then 15 acts as the unit so the Smarandache unit graph of the S -semigroup $\mathrm{P}_{2}$ is as follows:


Clearly the S-unit graph of $\mathrm{P}_{2}$ is not a tree. However the Szero divisor graph of $\mathrm{P}_{2}$ is a tree.

Example 3.37: Let us consider the semigroup $\mathrm{S}=\left\{\mathrm{Z}_{19}, \times\right\}$.
Clearly the zero divisor graph of S is a tree with 19 vertices given by


Clearly S is a S -semigroup for $\mathrm{P}=\{0,1,18\}$ is also a S semigroup as $\{1,19\}=\mathrm{G}$ is a group. Now the S zero divisor graph of P is also a tree with 3 vertices.


Now the S-unit graph of P is

is also a tree with 3 vertices. Now the unit graph of $S$ is not a tree.


In view of this we have the following theorem.
THEOREM 3.5: Let $S=\left\{Z_{p}, x\right\}$ be a semigroup; $p$ a prime.
(i) The unit graph of $S$ is not a tree.
(ii) The zero divisor graph of $S$ is a tree
(iii) $S$ has a S-unit graph which is a tree with 3 vertices.

Proof is direct and hence is left as an exercise to the reader.
Example 3.38: Let $\mathrm{S}=\left\{\mathrm{Z}_{40}, \times\right\}$ be a semigroup.

Take $P_{1}=\{0,2,4, \ldots, 38\}$ to be a subsemigroup of S.
The zero divisor graph of $\mathrm{P}_{1}$ is not a tree.
However the unit graph of P is a tree.
Consider $\mathrm{P}_{2}=\{1,10,20,30,0\}$ a subsemigroup of S .
The unit graph of $P_{2}$ is


The zero divisor graph of $\mathrm{P}_{2}$ is


However the zero divisor graph of $\mathrm{P}_{2}$ is not a tree.
Take $P_{3}=\{0,5,10,15,20,25,30,35,1\}$ be the subsemigroup of S . The zero divisor graph of $\mathrm{P}_{3}$ is


Clearly it is not a tree.

However the unit graph of $P_{3}$ is a tree given in the following.


Consider $\mathrm{P}_{4}=\{0,1,39\}$ a subsemigroup of S . The unit graph of $\mathrm{P}_{4}$ is


The zero divisor graph of $\mathrm{P}_{4}$ is


The S-unit graph of $\mathrm{P}_{4}$ is


In view of all this we have the following result.

THEOREM 3.6: Let $S=\left\{Z_{n}, x\right\}$ be a semigroup. $S$ is a $S$ semigroup with a special S-unit subgraph containing a point and a tree with 2 vertices and a special zero subgraph which is tree with 3 vertices.

Proof: Take $\mathrm{P}=\{0, \mathrm{n}-1,1\} \subseteq \mathrm{S} ; \mathrm{P}$ is a S-semigroup. The S unit graph associated with $P$ is

and the special zero divisor graph of P is

a tree with 3 vertices.
Next we proceed onto describe the unit graph of complex modulo integers.

Example 3.39: Let $\mathrm{C}\left(\mathrm{Z}_{2}\right)=\left\{0,1, \mathrm{i}_{\mathrm{F}}, 1+\mathrm{i}_{\mathrm{F}}\right\}$ be a semigroup of complex modul integers under product. The unit graph of $\mathrm{C}\left(\mathrm{Z}_{2}\right)$ is a tree with four vertices.


This is a $S$-semigroup and the $S$-unit graph of $C\left(Z_{2}\right)$ is


## Example 3.40: Let

$\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{3}\right), \times\right\}=\left\{0,1,2, \mathrm{i}_{\mathrm{F}}, 2 \mathrm{i}_{\mathrm{F}}, 1+\mathrm{i}_{\mathrm{F}}, 2+\mathrm{i}_{\mathrm{F}}, 1+2 \mathrm{i}_{\mathrm{F}}, 2+2 \mathrm{i}_{\mathrm{F}}\right\}$
be the complex modulo integer semigroup.
The unit graph of S is as follows.


Clearly the unit graph of S is not a tree.
The S -unit subgraph of $\mathrm{P}=\{0,1,2\}$ is a tree with two vertices and a point.

The special unit subgraph related with $P$ is a tree with 3 vertices.

Now we give the unit graph of M.


Clearly the unit graph of $M$ is not a tree.
Example 3.42: Let $\mathrm{N}=\left\{\mathrm{C}\left(\mathrm{Z}_{5}\right), \times\right\}$ be a semigroup of finite complex modulo integers. The unit graph of $\mathrm{C}\left(\mathrm{Z}_{5}\right)$ is not a tree. Follows from the simple fact $2.3 \equiv 1 \bmod (5)$.

In view of this we have the following result the proof of which is simple and direct.

THEOREM 3.7: Let $P=\left\{C\left(Z_{p}\right), x\right\}$ ( $p$ a prime) be a semigroup of finite complex modulo integers. The unit graph of $P$ is not a tree.

Example 3.43: Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{28}\right), \times\right\}$ be a semigroup of finite complex modulo integers. The unit graph of $S$ is not a tree.

Consider $\mathrm{i}_{\mathrm{F}}, 27 \mathrm{i}_{\mathrm{F}}$ is S we see $\mathrm{i}_{\mathrm{F}} \times 27 \mathrm{i}_{\mathrm{F}}=27 \mathrm{i}_{\mathrm{F}}^{2}=(27)^{2}=1$ so the unit graph is not a tree.

In view of this we have the following theorem.

Theorem 3.8: Let $S=\left\{C\left(Z_{n}\right), x\right.$, where $n$ is a composite number\} be a semigroup under $x$. The unit graph of $S$ is not a tree.

Proof: Follows from the simple fact $\mathrm{i}_{\mathrm{F}},(\mathrm{n}-1) \mathrm{i}_{\mathrm{F}}$ in S are such that $\mathrm{i}_{\mathrm{F}} \times(\mathrm{n}-1) \mathrm{i}_{\mathrm{F}}=(\mathrm{n}-1) \mathrm{i}_{\mathrm{F}}^{2}=(\mathrm{n}-1)^{2}=1$ as $\mathrm{i}_{\mathrm{F}}^{2}=\mathrm{n}-1$ in $\mathrm{C}\left(\mathrm{Z}_{\mathrm{n}}\right)$. Hence the claim.

Example 3.44: Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{25}\right), \times\right\}$ be a finite complex modulo integer semigroup. Consider the Smarandache subsemigroup $P=\left\{0,1, i_{F}, 24,24 i_{F}\right\} \subseteq S$. The Smarandache unit graph of $P$ is as follows:


Clearly this not a tree.
In view of this we have the following theorem.
Theorem 3.9: Let $P=\left\{C\left(Z_{n}\right), x\right\}$ be a finite complex modulo integer semigroup. $P$ has a Smarandache subsemigroup $S$ of order 5 and $S$ has a group of order 4. The Smarandache unit graph of $S$ is not a tree.

Proof: Consider $\mathrm{S}=\left\{0, \mathrm{i}_{\mathrm{F}}, 1\right.$, $\left.(\mathrm{n}-1),(\mathrm{n}-1) \mathrm{i}_{\mathrm{F}}\right\} \subseteq \mathrm{P}$ is a $\mathrm{S}-$ subsemigroup of S . The unit graph of S is as follows.


Clearly the unit graph is not a tree. The Smarandache unit graph of S is as follows:

this is also not a tree.
It is pertinent to mention that not all subgraphs of a unit graph correspond to a subsemigroup of the semigroup S . We call those unit subgraphs of the unit graph which corresponds to a subsemigroup as a special unit subgraph and the unit graph corresponding to a S-subsemigroup as special Smarandache unit subgraph.

We will only illustrate this situation by a few examples.
Example 3.45: Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{6}\right), \times\right\}$ be a semigroup of complex modulo integers. The unit graph associated with S is as follows.


We see the unit graph of S is not a tree. Consider the subgraph of this unit graph.


Clearly this is a tree but $\mathrm{V}=\left\{1, \mathrm{i}_{\mathrm{F}}, 2 \mathrm{i}_{\mathrm{F}}, 4 \mathrm{i}_{\mathrm{F}}, 5 \mathrm{i}_{\mathrm{F}}, 3 \mathrm{i}_{\mathrm{F}}\right\} \subseteq \mathrm{S}$ is not a subsemigroup as $3 \mathrm{i}_{\mathrm{F}} \times 2 \mathrm{i}_{\mathrm{F}} \equiv 0 \notin \mathrm{~V}$. However it is a subgraph of the graph.

Consider the subsemigroup $\mathrm{W}=\{0,1,2,3,4,5\} \subseteq \mathrm{S}$. The unit graph associated with W is as follows:


Clearly it is a tree and a special unit subgraph of S. Consider $\mathrm{V}=\left\{0,1, \mathrm{i}_{\mathrm{F}}, 5 \mathrm{i}_{\mathrm{F}}\right\} \subseteq \mathrm{S} ; \mathrm{V}$ is a Smarandache subsemigroup of S . The unit graph of V is as follows:


The Smarandache unit graph of V is


In view of this example we have the following theorem.
Theorem 3.10: Let $S=\left\{C\left(Z_{n}\right), x\right\}$ be a semigroup of finite modulo integers. Let $G$ be the unit graph of $S$. $S$ has both
subsemigroup unit special subgraphs of $G$ as well as subgraphs which are not associated with any subsemigroup of $G$.

The proof is direct and hence left as an exercise to the reader.

We can also find the direct product of finite complex modulo integer semigroups.

We will illustrate these situations only by examples.
Example 3.46: Let $\mathrm{S}=\mathrm{C}\left(\mathrm{Z}_{2}\right) \times \mathrm{C}\left(\mathrm{Z}_{2}\right)=\left\{(\mathrm{a}, \mathrm{b}) \mid \mathrm{a}, \mathrm{b} \in \mathrm{C}\left(\mathrm{Z}_{2}\right)=\right.$ $\left\{0,1, \mathrm{i}_{\mathrm{F}}, 1+\mathrm{i}_{\mathrm{F}}\right)$ with $\left.\mathrm{i}_{\mathrm{F}}^{2}=1\right\}$ be the semigroup of finite complex modulo integers.

Clearly S has 16 elements. The unit graph of S is as follows:


Clearly this is a tree with 16 vertices.

## Example 3.47: Let

\mathrm{S}=\mathrm{C}\left(\mathrm{Z}_{2}\right) \times \mathrm{C}\left(\mathrm{Z}_{3}\right)=\left\{(\mathrm{a}, \mathrm{~b}) \mid \mathrm{a} \in \mathrm{C}\left(\mathrm{Z}_{2}\right), \mathrm{b} \in \mathrm{C}\left(\mathrm{Z}_{3}\right)\right\}
$$

be a semigroup of finite complex modulo integers.
The number of elements in $S$ is 36 . The unit graph of $S$ is as follows:


We see the unit graph of S is not a tree. This has subgraphs which are trees. For instance consider $\mathrm{W}=\{(0,1),(0,2),(0$, $\left.\mathrm{i}_{\mathrm{F}}\right),\left(0,2 \mathrm{i}_{\mathrm{F}}\right),(0,0),\left(0,1+\mathrm{i}_{\mathrm{F}}\right),\left(0,1+2 \mathrm{i}_{\mathrm{F}}\right),\left(0,2+\mathrm{i}_{\mathrm{F}}\right),(1,1)(0$, $\left.\left.2+2 \mathrm{i}_{\mathrm{F}}\right)\right\} \subseteq \mathrm{S} ; \mathrm{W}$ is a subsemigroup. The unit graph associated with W is as follows:


Clearly the unit graph is a tree and this is the special unit subgraph of the unit graph associated with S.

Consider $\mathrm{V}=\left\{(0,0),(1,1),(1,0),\left(\mathrm{i}_{\mathrm{F}}, 0\right),\left(1+\mathrm{i}_{\mathrm{F}}, 0\right)\right\} \subseteq \mathrm{S}$ be the subsemigroup of S . The unit graph of V is as follows:


This is also a tree and this subgraph is the special unit subgraph of the unit graph of S.

In view of this we have the following interesting theorem.
THEOREM 3.11: Let $S=\left(C\left(Z_{n}\right) \times C\left(Z_{m}\right) \mid C\left(Z_{n}\right)\right.$ and $C\left(Z_{m}\right)$ are finite complex modulo intergers $\}=\left\{(a, b) \mid a \in C\left(Z_{n}\right)\right.$ and $b \in$ $\left.C\left(Z_{m}\right)\right\}$ be a complex modulo integer semigroup. The unit graph is not a tree but $S$ has two subsemigroups whose special unit subgraphs are trees with $(m+1)$ and $(n+1)$ vertices.

Proof: We know the unit graph associated with S is a not a tree. For take $\left(1, \mathrm{i}_{\mathrm{F}}\right)$ and $\left(1,(\mathrm{~m}-1) \mathrm{i}_{\mathrm{F}}\right) \in \mathrm{S}$; these two elements are inverses of each other, for

Similarly $\left((\mathrm{n}-1) \mathrm{i}_{\mathrm{F}}, 1\right)$ and $\left(\mathrm{i}_{\mathrm{F}}, 1\right)$ in S are such that

Thus the unit graph of $S$ is not a tree.
Now consider
$P=\left\{(1,1),(a, 0) \mid a \in C\left(Z_{n}\right) \times\{0\}\right)$ that is $\left.a \in Z_{n}\right\} \subseteq S, P$ is a semigroup with unit $(1,1)$. The unit graph of $P$ is a tree with $(\mathrm{n}+1)$ vertices. Infact this graph is a special unit subgraph of the unit graph associated with S .


Consider

\mathrm{M}=\left\{(1,1),(0, \mathrm{a}) \mid \mathrm{a} \in \mathrm{Z}_{\mathrm{m}} \text { or }(0, \mathrm{a}) \in\left\{\{0\} \in \mathrm{C}\left(\mathrm{Z}_{\mathrm{m}}\right)\right\}\right\} \subseteq \mathrm{S},
$$

M is a subsemigroup with unit $(1,1)$. Clearly the unit graph associated with M is

tree with $(m+1)$ vertices. Thus the unit graph is the special unit subgraph of the unit graph associated with S .

Example 3.48: Let $\mathrm{S}=\mathrm{C}\left(\mathrm{Z}_{3}\right) \times \mathrm{C}\left(\mathrm{Z}_{2}\right) \times \mathrm{C}\left(\mathrm{Z}_{4}\right)=\{(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mid \mathrm{a} \in$ $\mathrm{C}\left(\mathrm{Z}_{3}\right), \mathrm{b} \in \mathrm{C}\left(\mathrm{Z}_{2}\right)$ and $\left.\mathrm{c} \in \mathrm{C}\left(\mathrm{Z}_{4}\right)\right\}$ be a semigroup of complex modulo finite integers. The unit graph $G$ of $S$ is as follows:


Clearly G is not a tree. Consider $H=\{(a, 0,0),(1,1,1) \mid a \in$ $\left.\mathrm{C}\left(\mathrm{Z}_{3}\right)\right\} \subseteq \mathrm{S}, \mathrm{H}$ is a subsemigroup of S . The unit graph $\mathrm{G}_{1}$ of H is as follows:

$\left(2+2 \mathrm{i}_{\mathrm{F}}, 0,0\right) \quad(0,0,0)$
$G_{1}$ is a tree with 10 vertices and $G_{1}$ is a special unit subgraph of the unit graph G.

Take $\mathrm{P}=\left\{(0, \mathrm{a}, 0)\right.$ and $\left.(1,1,1) \mid \mathrm{a} \in \mathrm{C}\left(\mathrm{Z}_{2}\right)\right\} \subseteq \mathrm{S}, \mathrm{P}$ is a subsemigroup with unit $(1,1,1)$ of S . The unit graph $\mathrm{G}_{2}$ associated with the subsemigroup P is as follows.


Clearly the unit subgraph $G_{2}$ is a special unit subgraph of $G$ and is a tree with five vertices.

Consider $\mathrm{V}=\left\{(0,0, \mathrm{a})\right.$ and $\left.(1,1,1) \mid \mathrm{a} \in \mathrm{C}\left(\mathrm{Z}_{4}\right)\right\} \subseteq \mathrm{S}, \mathrm{V}$ is a subsemigroup of S . The unit graph $\mathrm{G}_{3}$ associated with V is as follows:

$\mathrm{G}_{3}$ is a special unit subgraph of G which is a tree with 17 vertices.

Let
$\mathrm{W}=\left\{(\mathrm{a}, \mathrm{b}, 0)\right.$ and $\left.(1,1,1) \mid(\mathrm{a}, \mathrm{b}, 0) \in \mathrm{C}\left(\mathrm{Z}_{3}\right) \times \mathrm{C}\left(\mathrm{Z}_{2}\right) \times\{0\}\right\} \subseteq \mathrm{S}$; W is a subsemigroup with unit of the semigroup S . The unit graph $\mathrm{G}_{4}$ associated with W is as follows.


Clearly $G_{4}$ is the special unit subgraph of $G$ which is tree with 37 vertices.

Consider
$\mathrm{B}=\left\{(0, \mathrm{a}, \mathrm{b}),(1,1,1) \mid(0, \mathrm{a}, \mathrm{b}) \in\{0\} \times \mathrm{C}\left(\mathrm{Z}_{2}\right) \times \mathrm{C}\left(\mathrm{Z}_{4}\right)\right\} \subseteq \mathrm{S} ;$ $B$ is a subsemigroup with unit of $S$. The unit graph $G_{5}$ associated with $B$ is as follows:


The unit graph $G_{5}$ of $G$ is a special unit subgraph of $G$ which is a tree with 65 vertices.

Finally let

\mathrm{C}=\left\{(\mathrm{a}, 0, \mathrm{~b}),(1,1,1) \mid(\mathrm{a}, 0, \mathrm{~b}) \in \mathrm{C}\left(\mathrm{Z}_{3}\right) \times\{0\} \times \mathrm{C}\left(\mathrm{Z}_{4}\right)\right\} \subseteq \mathrm{S} ;

be a subsemigroup of S . The unit graph $\mathrm{G}_{6}$ of C is as follows:


Clearly $\mathrm{G}_{6}$ is a unit graph and is a special unit subgraph of $G$ which is a tree with 145 vertices. We see $G$ has atleast 6 special unit subgraphs which are trees. Inview of this we have the following theorem.

THEOREM 3.12: Let $S=\left(C\left(Z_{n}\right) \times C\left(Z_{n}\right) \times \ldots \times C\left(Z_{n_{t}}\right)=\left\{\left(a_{1}\right.\right.\right.$, $\left.\left.a_{2}, \ldots, a_{t}\right) \mid a_{i} \in C\left(Z_{n_{1}}\right) ; 1 \leq i \leq t\right\}$ be a semigroup of complex modulo integers.
(1) The unit graph $G$ associated with $S$ is not a tree (all $n_{i} \neq 2$ )
(2) G has at least $t+{ }_{t} C_{2}+{ }_{t} C_{3}+\ldots+{ }_{t} C_{t-1}$ number of special unit subgraphs which are trees.

Proof follows using simple number theoretic techniques. Next we proceed onto define Smarandache units in semigroups.

DEfinition 3.2: Let (S, .) be semigroup with unit. We say $x \in$ $S \backslash\{1\}$ is a Smarandache unit (S-unit) if there exists $y \in S$ with
(i) $\quad x . y=1$
(ii) There exists $a, b \in S \backslash\{x, y, 1\}$
(a) $x a=y$ or $a x=y$ or
(b) $y b=x$ or by $=x$ and
(c) $a b=1$
(ii)a or (ii)b is satisfied it is enough to make x a S unit.

DEFINITION 3.3: Let $S$ be a semigroup with unit. Let $x \in S$ । $\{0\}$ be such that $x . y=1$ and $a x=y$ and $a y=x, a \in S$ then the special S-unit graph of the set $\{1, x, y, a\}$ as its vertices and the edges are 1 to $x, 1$ to $y x$ to $y$ and the edge 1 to $a$ is drawn as $a$ dotted edge; or can be usual edge.

The Special S-unit graph of $\{1, x, y, a\}$ is as follows:


Suppose we have instead of the set $\{1, x, y, a\}$ the set $\{1, x, y, a, b, a \neq b ; a b=1\}$ then the special S-unit graph of the set $\{1, \mathrm{x}, \mathrm{y}, \mathrm{a}, \mathrm{b}\}$ as its vertices is as follows:


The graphs are self explanatory. First we will illustrate this situation by some examples.

Example 3.49: Let $\mathrm{S}=\left\{\mathrm{Z}_{5}, \times\right\}$ be a semigroup with unit. Clearly $3 \in S$ is a $S$-unit for $2.3 \equiv 1(\bmod 5)$ and $4 \in Z_{5}$ is such that $4.2 \equiv 3(\bmod 5)$ and $4.3 \equiv 2(\bmod 5)$. The special S-unit graph of $\{1,2,3,4\}$ is as follows:


Example 3.50: Let $\mathrm{S}=\left\{\mathrm{Z}_{9}, \times\right\}$ be the semigroup with unit. Let $2 \in \mathrm{Z}_{9}$ is a S -unit of S as $5 \in \mathrm{Z}_{9}$ is such that $2.5 \equiv 1(\bmod 9)$ and $7,4 \in Z_{9}$ satisfies $2.7 \equiv 5(\bmod 9)$ and $4.5 \equiv 2(\bmod 9)$.

The special S-unit graph of $\{2,5,7,4,1\}$ is as follows:

DEfinition 3.4: Let $S$ be a semigroup with unit. An element $x$ $\in S \backslash\{1\}$ is said to be a super Smarandache unit of $S$ if there is a $y \in S$ with $x y=1(y \neq x)$ and $a, b \in S \backslash\{x, y, 1\}(a \neq b)$ with $\{a, b, x, y, 1\}$ as a S-unit. If there exist $a, c \in S \backslash\{a, b, x, y, 1\}$ with $c^{2}=1$ and $c a=b$ and $c b=a$ then we call $x$ to be $a$ Smarandache super unit in $S$. We can get the super special Smarandache unit graph of $S$ given by the set $=\{1, x, y, a, b, c\}$ is as follows:


We will first illustrate this situation by some examples.
Example 3.51: Let $\mathrm{S}=\left\{\mathrm{Z}_{9}, \times\right\}$ be a semigroup. Consider $2 \in$ S, we see $2 \times 5 \equiv 1(\bmod 9)$; so 2 is a unit. For we have 4 and 7 in $S$ such that $4.7 \equiv 1(\bmod 9)$, and $2.7 \equiv 5(\bmod 9)$ and $5.4 \equiv 2$ $(\bmod 9)$. Finally $8 \in \mathrm{~S}$ is such that $8.2 \equiv 7(\bmod 9)$ and $8.5 \equiv 4$ $(\bmod 9)$. Thus 2 is a Super Smarandache special unit of $S$. The Super special S-unit graph of 2 is as follows:

Example 3.52: Let $\mathrm{S}=\left\{\mathrm{Z}_{5}, \times\right\}$ be a semigroup S has no super special S-unit. For if a semigroup with unit should have a super special S-unit the order of S must be atleast six or greater than six. Since order of $S$ is five $S$ has no super special $S$-unit.

Example 3.53: Let $\mathrm{S}=\left\{\mathrm{Z}_{7}, \times\right\}$ be a semigroup with unit. Let $4,2 \in \mathrm{Z}_{7} \backslash\{0\}$ be such that $2.4 \equiv 1(\bmod 7)$ we see 5 and 3 in $S$ are such that $5.3=1(\bmod 7)$ and $3.4 \equiv 5(\bmod 7)$ and $5.2 \equiv 3$ $(\bmod 7), 6 \equiv \mathrm{Z}_{7}$ is such that $5($ or 3$)$ is a super special $S$-unit of S.

For the super special S-unit graph associated with the set $\{1,3,5,2,4,6\}$ is as follows:


The natural question is 5 and 3 are super $S$-units will 2 and 4 be super S-units. The answer is yes we see 2 and 4 are also super S-units for consider the set $\{1,2,4,5,3,6\}$ the super special Smarandache unit graph is as follows:


We see we do not have a S-unit graph of the form.


However these does not exist a S-unit graph of the form in $S=\left\{Z_{11}, \times\right\}$.


Now we give some more examples.
Example 3.54: Let $\mathrm{S}=\left\{\mathrm{Z}_{6}, \times\right\}$ be a semigroup. We see the only invertible element of $S$ is 5 . So $S$ has no $S$-unit.

Example 3.55: Let $\mathrm{S}=\left\{\mathrm{Z}_{8}, \times\right\}$ be a semigroup with unit. The elements in $S$ which are invertible are 7,3 and 5 with one.

Clearly $S=\left\{Z_{8}, \times\right\}$ does not have $S$-unit or super S-units.
Example 3.56: Let $\mathrm{S}=\left\{\mathrm{Z}_{10}, \times\right\}$ be semigroup with unit. 3 is a S unit and the Special Smarandache unit of 3 is and $3.7 \equiv 1$ $(\bmod 10), 9.3 \equiv 7(\bmod 10)$ and $7.9 \equiv 3(\bmod 10)$.


Clearly S has no Super Smarandache units.
Example 3.57: Let $S=\left\{Z_{12}, \times\right\}$ be a semigroup with unit. Clearly 5, 7 and 11 in S are units and all of them are self inversed element.

Example 3.58: Let $\mathrm{S}=\left\{\mathrm{Z}_{14}, \times\right\}$ be a semigroup with unit. $3 \in$ S is a super Smarandache unit of S . Take $\{1,3,5,9,11,13\} \subseteq$ $S$, the super special Smarandache unit of $S$ is as follows:


13
$0,2,7,4,6,8,10$ and 12 are zero divisors of $S$.
Example 3.59: Let $\mathrm{S}=\left\{\mathrm{Z}_{16}, \times\right\}$ be a semigroup with unit. 3 is a S-unit and the inverse of 3 is 11 for $3.11 \equiv 1(\bmod 16)$ and $9^{2} \equiv 1(\bmod 16)$.

The S-unit graph of 3 is


Also 13 is a $S$ unit of $S$ for $13.5 \equiv 1(\bmod 16)$ and the $S$ unit graph of 13 is as follows:


However S has no super S-unit.
Example 3.60: Consider $\mathrm{S}=\left\{\mathrm{Z}_{15}, \times\right\}$ be a semigroup with unit. Clearly S has no super S units. However S has two sets of S units whose Special S-unit graph is as follows.


Example 3.61: Let $\mathrm{S}=\left\{\mathrm{Z}_{18}, \times\right\}$ be a semigroup with unit. 11 and 13 are two super Smarandache super Smarandache special unit graphs.


Example 3.62: Let $\mathrm{S}=\left\{\mathrm{Z}_{20}, \times\right\}$ be a semigroup with unit. We see $3 \times 7 \equiv 1(\bmod 20), 9^{2} \equiv 1(\bmod 20), 11^{2} \equiv 1(\bmod 20), 19^{2} \equiv$ $1(\bmod 20)$ and $13 \times 17 \equiv 1(\bmod 20)$. Clearly S has no super Smarandache units but $S$ has S-units.

For 3 is a $S$-unit and the special $S$-unit graph of 3 is as follows:


Also 13 is a S-unit and the special S-unit graph associated with 13 is as follows:

However 2 is not a super $S$-unit. 4 is also a $S$-unit and not a Super S-unit, the special S-unit graph of 4 is


3 is also only a S-unit and not a super S-unit for $3 \times 17=1$ $(\bmod 25)$ and 9,14 in $S$ are such that

However both 16 and 6 are not super $S$ units of S. Further 12 (23), and 8 (22) are not even $S$ units they are only units.

But 12 or 23 and 8 or 22 are not $S$ units even of the above form.

Next we proceed onto define the notion of quasi Smarandache unit triple.

DEFINITION 3.5: Let $S=\left\{Z_{n}, x\right\}$ be a semigroup with unit. If we have a triple $\{x, y, z\} \in Z_{n} \backslash\{1\}$ such that

First we will illustrate this situation by some examples.
Example 3.64: Let $\mathrm{S}=\left\{\mathrm{Z}_{8}, \times\right\}$ be a semigroup with unit. $7 \in$ Z is such that $7^{2} \equiv 1(\bmod 8) 5 \in \mathrm{~s}$ is such that $5^{2} \equiv 1(\bmod 8)$ and $3 \in S$ is such that $3^{2} \equiv 1(\bmod 8)$. The other elements 4,2 and 6 are zero divisors in S .

The triple $\{5,3,7\}$ is a quasi S-unit triple for $5 \times 3 \equiv 7(\bmod 8) \quad 3 \times 7 \equiv 5(\bmod 8)$ and $7 \times 5 \equiv 3(\bmod 8)$.

The quasi S-unit triple graph is as follows:


Example 3.65: Let $\mathrm{S}=\left\{\mathrm{Z}_{6}, \times\right\}$ be a semigroup with unit S has no quasi triple S-unit.

Example 3.66: Consider $\mathrm{S}=\left\{\mathrm{Z}_{15}, \times\right\}$ be a semigroup with unit. $\{11,14,4\} \in \mathrm{S}$ is a quasi triple S -unit of S . For $4^{2} \equiv 1(\mathrm{mod}$ $15), 14 \equiv 1(\bmod 15)$ and $11^{2} \equiv 1(\bmod 15)$.

Further $4 \times 11=14(\bmod 15), 4 \times 4=11(\bmod 15)$, and $11 \times 4=4(\bmod 15)$.

The quasi S-unit graph with $\{1,4,11,14\}$ as its vertices are as follows:


Example 3.67: Let $S=\left\{Z_{10}, \times\right\}$ be a semigroup with unit. Clearly S has no quasi S -unit.

Example 3.68: Let $S=\left\{Z_{14}, \times\right\}$ be a semigroup with unit. $S$ has no quasi S -unit.

Example 3.69: Let $\mathrm{S}=\left\{\mathrm{Z}_{22}, \times\right\}$ be a semigroup wth unit. S has no quasi S-unit.

Inview of this we have the following theorem.

THEOREM 3.13: Let $S=\left\{Z_{2 p}, x\right\}$ be a semigroup with unit. $p$ a prime. $S$ has no quasi $S$-unit.

The proof is using only simple number theoretic methods. We can also have following corollary.

Corollary 3.1: Let $S=\left\{Z_{2 p}, \times\right\}$ be a semigroup with unit (p a prime). All even numbers with p are zero divisors. Further odd numbers in $Z_{2 p}$ baring $(2 p-1)$ alone can result in the unit.

We now find whether $S$ in example 3.67 has super $S$-units and S-units.

Example 3.70: Let $\mathrm{S}=\left(\mathrm{Z}_{11}, \times\right)$ be a semigroup with unit. Clearly $S$ does not contain a quasi S-unit triple. However 6 (or z) is a S-unit, but 6 (or z ) is a super S-unit. Also 9 (or 5 ) is a Sunit.

The special S-unit graph of them are as follows:


Example 3.71: Let $\mathrm{S}=\left(\mathrm{Z}_{13}, \times\right)$ be a semigroup with unit. We see $S$ has no quasi $S$-unit. 2 is a $S$-unit. For special $S$ unit graph associated with 2 in S is as follows:


Other units in S are not S -unit.
In view of this we have the following theorem.
THEOREM 3.14: Let $S=\left\{Z_{p}, x\right\}$ be a semigroup with unit, $p$ a prime. S has no quasi S-unit triple.

The proof is direct and uses only the fact $Z_{p}$ is a field.
Now we leave the following as a open problem.
Problem 1: Let $S=\left\{Z_{p}, \times\right\}$ be a semigroup with unit
(i) Can S have super S -unit?
(ii) How many S-unit can $\mathrm{Z}_{\mathrm{p}}$ have?

Thus we have a class of semigroups which contain quasi Sunits.

Other open problems are as follows:
Problem 3: Can the symmetric semigroup S(n) have S-unit?
Problem 4: Can the symmetric semigroup $\mathrm{S}(\mathrm{n})$ have super S units?

Now for even $S(n)$ the symmetric semigroup contains $S_{n}$ the symmetric group in $S(n)$, so $S(n)$ is a $S$-semigroup.

The unit graph of $S(n)$ is the graph of the group $S_{n}$. For graphs of groups please refer [15].

Now we consider the semigroup $S=\left(Z_{11}, \times\right)$. We see the units of $Z_{11}$ are 1 ,

Finally $p a=q(\bmod n)$
$q b=p(\bmod n)$. Further $r u=s(\bmod n)$
$s t=r(\bmod n)$ then we define $\{(p, q),(r, s),(t, u)$ and $(a, b)\}$ as a 4-tuple super super chain like S-unit. The graph is called the 4-tuple super super chain like S-unit graph with vertices \{1, $p, q, r, s, t, u, a, b$ and $n-1\}$. The 4 -tuple graph is as follows:


An important problem is will every $\left(Z_{p}, x\right)$ with $p \geq 11$ have a 4-tuple super super chain like S -unit?

Example 3.74: Let $\mathrm{S}=\left(\mathrm{Z}_{13}, \times\right)$ be a semigroup with unit. Clearly $12 \times 12 \equiv 1(\bmod 13)$. The units of $S$ are $2 \times 7 \equiv 1(\bmod$ $13), 3 \times 9 \equiv 1(\bmod 13), 4 \times 10 \equiv 1(\bmod 13), 5 \times 8 \equiv 1(\bmod$ $13), 6 \times 11 \equiv 1(\bmod 13)$ and $12^{2}=1(\bmod 13)$.

We can have a 4-tuple super super chain like S-unit.


We can also have a 5 -tuple super super chain like S -unit, using the 5 pairs $(3,9),(2,7),(4,10),(5,8),(6,7)$ and 1 and 12 . The graph is given in the following.


We will get a 5 -tuple super super chain like S -units. We see this graph is also a complete graph with 12 vertices.

In view of this we have the following theorem.
THEOREM 3.16: Let $S=\left\{Z_{p}, x\right\}$ semigroup with unit ( $p$ a prime). $S$ has ( $p-3$ )/2 sets of distinct units like $a, b \in S, a \neq b$ but $a \times b \equiv 1(\bmod p)$ and $(p-1)^{2} \equiv 1(\bmod p) . S$ has $a(p-3)$ tuple super super chain like S-units. Further the ( $p-1$ )/2 tuple super super chain like S-unit graph has (p-1) vertices and is a complete graph.

The proof is direct and only involves simple number theoretic techniques.

If $p=3$ then $S=\left\{Z_{3}, \times\right\}$ has no S-unit.
If $p=5$ then $S=\left\{Z_{5}, \times\right\}$ has units of the form.
The unit graph of $\{1,4,2,3\}$ is as follows:


Clearly S has a S -unit and the unit graph is a complete graph with four vertices.

If $\mathrm{p}=7$ then $\mathrm{S}=\left\{\mathrm{Z}_{7}, \times\right\}$ has units of the form $6^{2} \equiv 1(\bmod$ 7), $5.3 \equiv 1(\bmod 7) 2 \times 4 \equiv 1(\bmod 7)$.

The unit graph with the vertices $\{1,6,2,4,5,3\}$ is as follows:


Clearly the S -unit is a special S -unit and the graph is a complete graph with six vertices.

Now we wish to bring this to the notice of the reader.
If we consider $Z_{p}$, we see $\left\{Z_{p} \backslash\{0\}, \times\right\}$ is an abelian group and we can draw a special super graph of $Z_{p} \backslash\{0\}$ and that will be the complete graph with ( $\mathrm{p}-1$ ) vertices. It may be recalled we have the diherdral group has a complete graph related to the conjugacy classes. However here we cannot talk of such relation of basically $\mathrm{Z}_{\mathrm{p}} \backslash\{0\}$ is an abelian group.

Now another natural question is can $\mathrm{S}=\left\{\mathrm{Z}_{\mathrm{n}}, \times\right\}$, n ; not a prime have $t$-tuple super super S-units?

We study this in the first phase by some examples.
Example 3.75: Let $\mathrm{S}=\left\{\mathrm{Z}_{15}, \times\right\}$ be a semigroup with unit. 1, $14,2 \times 8 \equiv 1(\bmod 15), 4^{2} \equiv 1(\bmod 15), 11^{2} \equiv 1(\bmod 15)$, $7 \times 13 \equiv 1(\bmod 15)$. Clearly $\mathrm{S}=\left(\mathrm{Z}_{15}, \times\right)$ cannot have super super S -unit. However it has a S -unit.


Example 3.76: Let $\mathrm{S}=\left\{\mathrm{Z}_{18}, \times\right\}$ be a semigroup with unit. The units of $S$ are $\left\{1,17^{2} \equiv 1(\bmod 18), 5 \times 11 \equiv 1(\bmod 18)\right.$, $7 \times 13 \equiv 1(\bmod 18)\}$. Clearly $S$ has no super S-units.

We now draw the unit graph of in example 3.75 and 3.76 respectively.


It is also a complete graph with 8 vertices.
Consider unit graph of the semigroup $S=\left\{Z_{18}, \times\right\}$ given in example 3.76.

The set of units of $\mathrm{Z}_{18}$ is as follows: $\{1,17,5,11,7,13\}$


The unit graph of $Z_{18}$ is a complete graph with 6 vertices.
Example 3.77: Consider the semigroup $\mathrm{Z}_{21}$ under product. The set of units in $\mathrm{Z}_{21}$ are $\left\{1,20^{2} \equiv 1(\bmod 21), 2 \times 11 \equiv 1(\bmod 21)\right.$, $8^{2} \equiv 1(\bmod 21), 4 \times 16 \equiv 1(\bmod 21), 5 \times 17 \equiv 1(\bmod 21), 10 \times$ $\left.19 \equiv 1(\bmod 21), 13^{2} \equiv 1(\bmod 21)\right\}$. We get a complete unit graph with 12 vertices.

Example 3.78: Let $\mathrm{S}=\left(\mathrm{Z}_{10}, \times\right)$ be a semigroup with unit. The units of $S$ are $\{1,9,3 \times 7\}$ has a $S$ unit of the form.


Example 3.79: Consider the semigroup $S=\left\{Z_{33}, \times\right\}$. The units in $S$ are $\{1,32,2 \times 7 \equiv 1(\bmod 33), 4 \times 25 \equiv 1(\bmod 33), 5 \times 20$ $\equiv 1(\bmod 33), 102 \equiv 1(\bmod 33), 29 \times 8 \equiv 1(\bmod 33), 19 \times 7 \equiv$ $1(\bmod 33)(23)^{2} \equiv 1(\bmod 33), 31 \times 16 \equiv 1(\bmod 33), 13 \times 28 \equiv$ $1(\bmod 33)$ and $14 \times 26 \equiv 1(\bmod 33)\}$.

We see $S$ is a 8 tuple super super chain like S -unit. The 8tuple super super chain $S$-unit graph has 20 vertices which is a complete graph.

Example 3.80: Let $\mathrm{S}=\left\{\mathrm{Z}_{25}, \times\right\}$ be a semigroup with unit.

$$
\begin{gathered}
\text { The units of S are }\left\{1,24^{2} \equiv 1(\bmod 25),\right. \\
13 \times 2 \equiv 1(\bmod 25), 3 \times 17 \equiv 1(\bmod 25), \\
4 \times 19 \equiv 1(\bmod 25), 21 \times 6 \equiv 1(\bmod 25), \\
7 \times 18 \equiv 1(\bmod 25), 8 \times 22 \equiv 1(\bmod 25), \\
9 \times 14 \equiv 1(\bmod 25), 23 \times 12 \equiv 1(\bmod 25) \text { and } \\
16 \times 11 \equiv 1(\bmod 25)\}
\end{gathered}
$$

This semigroup has 9 -tuple super super chain like S-unit and the graph associated with it is a complete graph with 20 vertices.

It is left as open problems.
Problem 5: If $S=\left\{Z_{p^{2}}, \times\right.$, p a prime $\}$ be a semigroup with unit. Can $S$ have more than one element x such that $\mathrm{x} \times \mathrm{x} \equiv 1$ $\left(\bmod \mathrm{p}^{2}\right)$ barring 1 and $\left(\mathrm{p}^{2}-1\right)^{2} \equiv 1\left(\bmod \mathrm{p}^{2}\right)$.

Study in this direction is innovative.
Problem 6: Can
$\mathrm{S}=\left\{\mathrm{Z}_{\mathrm{pq}} \mid \mathrm{p}\right.$ and q are primes $\mathrm{p} \neq \mathrm{q}, \mathrm{p}=3$; q any other prime $\}$ have $t$-tuple super super chain like $S$-units?

Example 3.81: Let $\mathrm{S}=\left(\mathrm{Z}_{30}, \times\right)$ be a semigroup with unit.
The unit set of $S$ is as follows:

$$
\begin{gathered}
\mathrm{T}=\left\{1,29^{2} \equiv 1(\bmod 30), 11^{2} \equiv 1(\bmod 30),\right. \\
13 \times 7 \equiv 1(\bmod 30), 19^{2} \equiv 1(\bmod 30) \text { and } \\
23 \times 17 \equiv 1(\bmod 30)\}
\end{gathered}
$$

The unit graph of T is as follows:


In view of all these examples we have the following theorem.

THEOREM 3.17: Let $S=\left\{Z_{n}, x\right\}$ be a semigroup with unit. The set of units in $S$ is a complete graph.

The proof is direct and hence left as an exercise to the reader.

It is important to mention that in case of rings using $\mathrm{Z}_{\mathrm{n}}$ the unit graph of all rings follows the same pattern as that of semigroups $S=\left(Z_{n}, \times\right)$. Further the same hold good for Smarandache units in rings, however these unit set will not be a subring of the ring $Z_{n}$.

Now we proceed onto describe the S-units in $C\left(Z_{n}\right)$.
Example 3.82: Let $\mathrm{C}\left(\mathrm{Z}_{2}\right)=\left\{0,1, \mathrm{i}_{\mathrm{F}}, 1+\mathrm{i}_{\mathrm{F}}\right\}$ be a complex modulo integer semigroup under has no S-unit. The unit graph of $C\left(Z_{2}\right)$ is


Example 3.83: Let $\mathrm{C}\left(\mathrm{Z}_{3}\right)=\left\{0,1,2, \mathrm{i}_{\mathrm{F}}, 2 \mathrm{i}_{\mathrm{F}}, 1+\mathrm{i}_{\mathrm{F}}, 1+2 \mathrm{i}_{\mathrm{F}}, 2+\mathrm{i}_{\mathrm{F}}\right.$, $\left.2+2 \mathrm{i}_{\mathrm{F}}\right\}$ be a semigroup under product. The units of $\mathrm{C}\left(\mathrm{Z}_{3}\right)$ are $1, \mathrm{i}_{\mathrm{F}} \times 2 \mathrm{i}_{\mathrm{F}}=1(\bmod 3), 2 \times 2 \equiv 1(\bmod 3),\left(1+\mathrm{i}_{\mathrm{F}}\right)\left(2+\mathrm{i}_{\mathrm{F}}\right) \equiv 1$ $(\bmod 3)$ and $\left.\left(1+2 \mathrm{i}_{\mathrm{F}}\right)\left(2+2 \mathrm{i}_{\mathrm{F}}\right)=1(\bmod 3)\right\}$.

The unit graph of $\mathrm{C}\left(\mathrm{Z}_{3}\right)$ is as follows:

Clearly the unit graph of $\mathrm{C}\left(\mathrm{Z}_{3}\right)$ is a complete graph with 8 vertices.

Clearly $\mathrm{i}_{\mathrm{F}}$ is a S -unit; likewise $\mathrm{Zi}_{\mathrm{F}}, 1+\mathrm{i}_{\mathrm{F}}$ and $2+\mathrm{i}_{\mathrm{F}}$ are S -units of $C\left(Z_{3}\right)$. Infact $C\left(Z_{3}\right)$ has a 3-tuple super super chain like $S$ unit.

Example 3.84: Let $\mathrm{C}\left(\mathrm{Z}_{4}\right)=\left\{\mathrm{a}+\mathrm{bi}_{\mathrm{F}} \mid \mathrm{a}, \mathrm{b} \in \mathrm{Z}_{4}, \mathrm{i}_{\mathrm{F}}^{2}=3\right\}$ be a complex modulo integer semigroup under $\times$.

The units of $\mathrm{C}\left(\mathrm{Z}_{4}\right)$ are $=\left\{1,3^{2} \equiv 1(\bmod 4), 3 \mathrm{i}_{\mathrm{F}} \times \mathrm{i}_{\mathrm{F}} \equiv 1\right.$ $(\bmod 4),\left(1+2 \mathrm{i}_{\mathrm{F}}\right)^{2}=1(\bmod 4),\left(2+\mathrm{i}_{\mathrm{F}}\right)\left(2+3 \mathrm{i}_{\mathrm{F}}\right) \equiv 1(\bmod 4)$ and $\left.\left(3+2 \mathrm{i}_{\mathrm{F}}\right)^{2}=1(\bmod 4)\right\}$.

For $\mathrm{C}\left(\mathrm{Z}_{4}\right)$ also the unit graph is a complete graph with 8 vertices.

However it not the same type as the unit graph given in example 3.83.

However this unit graph is not a 3-tuple super super chain like S -unit. Now this semigroup has S -unit.

We can find the unit graph of $\mathrm{C}\left(\mathrm{Z}_{5}\right)$.
Example 3.85: Let $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{5}\right), \times\right\}$ be a semigroup. The units of $S$ are as follows:

$$
\mathrm{T}=\left\{1,2 \times 3 \equiv 1(\bmod 5), 4, \mathrm{i}_{\mathrm{F}} \times 2 \mathrm{i}_{\mathrm{F}} \equiv 1(\bmod 5), 3 \mathrm{i}_{\mathrm{F}} \times 4 \mathrm{i}_{\mathrm{F}} \equiv\right.
$$ $1(\bmod 5),\left(1+\mathrm{i}_{\mathrm{F}}\right) \times\left(3+2 \mathrm{i}_{\mathrm{F}}\right) \equiv 1(\bmod 5)\left(3 \mathrm{i}_{\mathrm{F}}+2\right)\left(4+4 \mathrm{i}_{\mathrm{F}}\right) \equiv 1$ $(\bmod 5),\left(3+3 \mathrm{i}_{\mathrm{F}}\right)\left(1+4 \mathrm{i}_{\mathrm{F}}\right)=1(\bmod 5)$ and $\left(4+\mathrm{i}_{\mathrm{F}}\right)\left(2+2 \mathrm{i}_{\mathrm{F}}\right)=1$ $(\bmod 5)\}$.

T has a unit graph which is a complete graph with 16 vertices. S has a 7 -tuple super super chain like S -unit. It has only two elements such that $4^{2} \equiv 1(\bmod 5)$ and $1^{2} \equiv 1(\bmod 5)$.

Further the zero divisor graph of S is not a tree. However $\mathrm{C}\left(\mathrm{Z}_{5}\right)$ has no nilpotent elements and the zero divisor graph of S is as follows:


In view of all these we have the following results.
THEOREM 3.18: Let $S=\left\{\left(C\left(Z_{p}\right), x\right\}\right.$ ( $p$ a prime) be a semigroup with unit and no zero divisors. The unit graph of $S$ is a complete graph with $p^{2}-1$ vertices and $S$ has a t-tuple super super chain like $S$-unit $(t \leq n)$.

Proof is direct and hence left as an exercise to the reader.

Suppose $\mathrm{S}=\left\{\mathrm{C}\left(\mathrm{Z}_{\mathrm{p}}\right), \times\right\}$ is a semigroup with unit and zero divisors. Can S have nilpotent elements? Suppose S has a mtuple. What is the exact value of $m$ ? We see when $p=5$ then $S$ has a 7 -tuple super super chain like $S$-unit.

When $\mathrm{p}=3$, we have S has a 3 -tuple super super chain like S-unit.

Interested reader can study this sort of S -units in $\mathrm{C}\left(\mathrm{Z}_{\mathrm{n}}\right)$, n prime as well as n-non prime.
